# DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

#### Lower

JCI weakened and closed at 6,750 (-53 points or -0.78%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 652Bn today and rupiah slightly strengthened to IDR 16,275/USD.

Banking stocks were mixed as BBRI (+0.77%) and BNLI (+12.08%) up, while BBNI (-2.33%), BMRI (-0.99%), and BBCA (-0.83%) declined. Consumer names were mixed as ICBP (+3.26%) and INDF (+2.6%) up, while MYOR (-0.87%), UNVR (-1.94%), and KLBF (-0.82%) retreated. Telco stocks were negative as FREN (-4.17%), ISAT (-3.18%), and TLKM (-1.89%) all declined. Retailer names were mixed as MAPI (+3.5%) and AMRT (+0.4%) in green, while MAPA (-0.6%) and ACES (-3.27%) corrected. Other movers were DWGL (+25%), MSIN (+11.21%), CMNP (-13.64%), and RAJA (-8.33%).

The government has disbursed people's business credit (KUR) amounting to Rp7.06tn to 15.6k debtors until February 15, 2025. This realization is equivalent to 7.05% of the KUR disbursement target for 2025 of Rp300tn.

# **BOND MARKET**


#### WITHIN RANGE

Indonesia bond market closed the day relatively flat. The mixed sentiment continued to be seen in the bond market today with the bond price opened around the same level as last friday closing. We witnessed several sporadic activity although the volume was very limited. Overall, IDR bonds yield lower 1 - 2 bps compared to last friday closing and IDR bonds still traded within range. The benchmark of 5Y, 10Y, 15Y and 20Y closed at mid yields of 6.53 %, 6.77%, 7% and 7.01% respectively. There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold sukuk bond auction with issuance target at IDR 10Tn


