EQUITY MARKET

SANK

JCI weakened and closed at 5,992 (-126 points or -2.06%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 312Bn today and rupiah slightly weakened to IDR 14,403/USD.

Banking stocks were negative as BBTN (-3.86%), BDMN (-3.04%), BBNI (-2.3%), BMRI (-3.31%), and BBRI (-4.67%) all weakened. Consumer names were negative as MYOR (-2.69%), ICBP (-2.4%), KLBF (-4.58%), HMSP (-2.53%), and UNVR (-2.84%) all declined. Mining stocks were negative as ITMG (-2.44%), INCO (-2.07%), PTBA (-4.44%), ADRO (-3.36%), and ANTM (-5.42%) all weakened. Retailer names were negative as LPPF (-3.29%), MAPI (-4.93%), ACES (-3.33%), and AMRT (-6.11%) all weakened. Other movers were RELI (+24.82%), SQMI (+15.83%), AGRO (-5.66%), and BRIS (-5.07%).

Jakarta raise mall capacity to 50% during PPKM (16-23 Aug) - Previously mall capacity is only allowed up to 25%. Business activities in mall will be between 10am to 8pm.

SLOW DAY



In the afternoon, Bank Indonesia announced that the central bank keep 7-days repo rate unchanged at 3.5% as expected.




