DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

DOWN

JCI weakened and closed at 6,553 (-38 points or -0.58%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 89Bn today and rupiah weakened to IDR 14,248/USD.

Banking stocks were negative as BDMN (-3.72%), BBNI (-2.14%), BBRI (-0.47%), MEGA (-5.46%), and BBCA (-1%) all declined. Consumer names were mixed as GGRM (+0.67%) and MYOR (+0.43%) inched higher, while KLBF (-0.63%), INDF (-1.18%), and HMSP (-0.97%) corrected. Infra stocks were negative as JSMR (-1.9%), PGAS (-1.99%), TOWR (-1.29%), and TBIG (-4.08%) all retreated. Telco names were mixed as ISAT (+5.78%) and FREN (+3.7%) advanced, while TLKM (-2.63%) retreated. Other movers were ANJT (+18.93%), INPP (+12.93%), BINA (-4.53%), and BTPS (-3.67%).

BI projects the value of e-commerce transactions to increase to Rp406tn, growing 52.6% YoY. The original projection was only Rp395tn. Meanwhile, digital banking transactions throughout this year are also projected to increase to Rp39,130tn or up 43% YoY.

SLIGHTLY LOWER


Indonesia bond market start the week weaker with wide spread today. Bond prices went down slightly in the morning session as Rupiah weakening to above 14,200 level. We heard some onshore and offshore players were on selling mode while onshore name on the buy side. Overall sentiment remains cautious ahead of FOMC meeting this week. From our side, we only heard 10Y FR87 was traded repeatedly at 6.23%. Rupiah closed at 14,275 in the spot market. Tomorrow on November 02 MoF will hold regular Sukuk auction of 6M SPNS, 3Y PBS-031, 5Y PBS-032, 13Y PBS-029, and 25Y PBS-028 with indicative target of IDR 4Tn.




