DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Weaker

JCI slightly weakened and closed at 6,915 (-27 points or -0.39%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 387Bn today and rupiah slightly weakened to IDR 15,204/USD.

Banking stocks were negative as BBNI (-0.26%), PNBN (-4.05%), MEGA (-6.88%), BBCA (-0.84%), and BMRI (-1.45%) all weakened. Consumer names were mostly negative as UNVR (-0.22%), HMSP (-0.95%), INDF (-1.11%), and KLBF (-0.86%) all retreated, except MYOR (+1.54%). Properties stocks were negative as PWON (-0.86%), BSDE (-1.58%), CTRA (-2.07%), and SMRA (-4.07%) all closed lower. Telco names were negative as ISAT (-1.59%), FREN (-2.9%), and TLKM (-0.26%) all corrected. Other movers were BRIS (+15.83%), BISI (+5.59%), MEDC (-4.51%), and INCO (-2.46%).

Bank Indonesia plans to expand the cross-border QR payment cooperation with India, China and Saudi Arabia. Currently, Indonesia has signed agreement on cross-border QR payment cooperation with Thailand, Singapore, Malaysia, Philippines and Japan.


LACKLUSTER TRADING

Bond market opened wider as price quotation continued its downward movement from yesterday following 10Y UST yield higher at 3.75%. Several selling activities were seen especially on 5Y and 10Y series but the trade volumes were small until the trading session end. Weakness in bond was in line with that in USD/IDR as the pair closed higher at 15,200/210. In the meantime, market waiting for BI rate announcement scheduled to be released tomorrow.


