DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

STILL UP

JCI recorded 5 consecutive gains and closed at 4,989 (+15 points or +0.3%) today. Shares across regional markets were mostly positive with Shanghai Composite closed up +5.7%, the biggest advance since 2015 after China's influential state media stoked bullish enthusiasm. Meanwhile, foreign investors recorded net outflow of IDR 547Bn today and rupiah slightly strengthened to IDR 14.490/USD.

Banking stocks were mostly positive as BBCA (+1.11%), BMRI (+1.5%), BBNI (+1.1%), and BNLI (+0.79%) all up, except BBRI (-0.33%). Consumer names were mostly negative as MYOR (-0.44%), INDF (-0.75%), GGRM (-0.85%), and HMSP (-0.89%) all corrected, except KLBF (+2.34%). Poultry stocks were positive as CPIN (+7.88%), JPFA (+4.26%), and MAIN (+3.25%) all advanced. Mining names were positive as INCO (+7.19%), ANTM (+6.67%), ADRO (+2.4%), TINS (+4.92%), and PTBA (+0.98%) all rose. Other movers were INPP (+21.93%), HITS (+19.05%), POLL (-6.44%), and MAPI (-2.7%).

MoF will increase the budget for MoH by IDR 25Tn for Covid-19 management. Total budget reached IDR 87.55Tn, while realisation was 4.68% up to 24th Jun 2020.

UNEVENTFUL

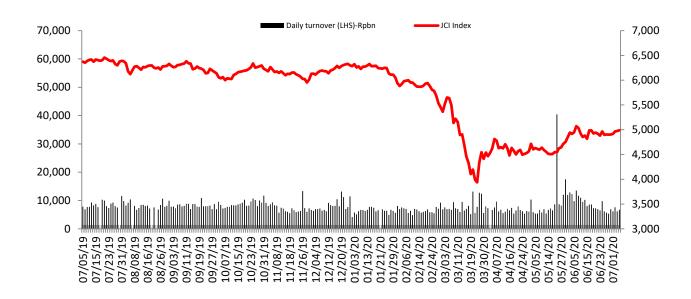
IDR bond market opened the day unchanged despite local currency weakens against USD, opening the day at 14,560 level. Nothing much happened in the bond market today. Limited activities remained focus on 5Y and 10Y area while the other part of the yield curve was quoted within range throughout the day. From our side we heard trade done in 5Y FR81 which was traded at 100.05 (6.48%) and 10Y FR82 given at 98.5 (7.20%).

Tomorrow, MoF will hold regular Sukuk auction of 6M SPNS, 2Y PBS-002, 4Y PBS-026, 14Y PBS-022, 23Y PBS-005 and 26Y PBS-028 with indicative target of IDR 7tn.

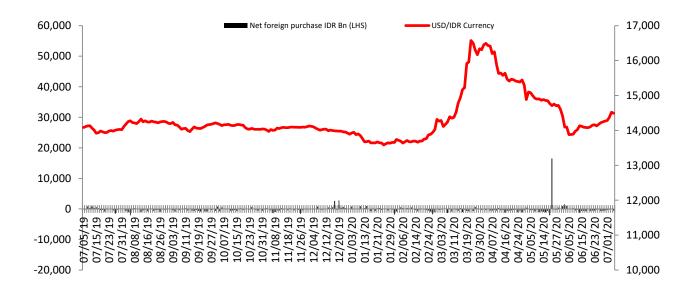
