DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Rally

JCI advanced and closed at 6,875 (+139 points or +2.06%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 372Bn today and rupiah was stabilized at IDR 14,988/USD.

Banking stocks were positive as BBRI (+4.62%), BMRI (+6.4%), BBCA (+3.14%), BBNI (+5.14%), and BBTN (+2.09%) all rose. Consumer names were mostly positive as KLBF (+1.76%), MYOR (+2.11%), GGRM (+0.76%), and SIDO (+1.04%) all up, except INDF (-0.7%). Poultry stocks were positive as CPIN (+1.72%), JPFA (+4.07%), and MAIN (+1.64%) all in green. Telco names were positive as TLKM (+1.2%), ISAT (+2.81%), and EXCL (+1.2%) all advanced. Other movers were ESSA (+11.46%), BUMI (+5.06%), LPPF (-3.45%), and NATO (-2.65%).

38.2% increase in value-added tax revenue to IDR300.9tn in the first half of 2022, pushed by the increase of tax rates from 10% to 11%. However, increased inflation in the last 2 months indicate a threat to shave off spending power, possibly affecting tax revenue as well.

BOND MARKET


FLATTISH

The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Morning session saw selling interest started by offshore players. While on the afternoon session as we witnessed mixed names showed their buying interest particularly after London opened although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive. In the meantime, market waiting for BI rate announcement scheduled to be released tomorrow.


