DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHTLY UP

JCI slightly strengthened and closed at 6,663 (+10 points or +0.15%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 659Bn today and rupiah slightly strengthened to IDR 14,343/USD.

Banking stocks were mixed as BBRI (+0.73%), BBNI (+1.11%), and BDMN (+0.84%) inched higher, while BMRI (-1.04%) and BBCA (-1.02%) closed lower. Consumer names were mostly negative as MYOR (-0.93%), INDF (-1.13%), ICBP (-1.13%), and UNVR (-1.13%) all closed lower, except HMSP (+1.49%). Material stocks were positive as TPIA (+3.89%) and BRPT (+0.57%) all in green. Telco names were mixed as EXCL (+1.6%) up, while FREN (-3.23%) and TLKM (-1.69%) weakened. Other movers were BMAS (+24.84%), BRAM (+18.1%), GEMS (-6.13%), and UNTR (-4.24%).

Govt finalized 2022 average excise hike at \sim 12%, slightly lower than the increase in 2021 (\sim 12.5%).

LIMITED ACTIVITY


IDR bond market relatively quiet in the morning session with prices moved within range lacking fresh catalyst. There was no significant price movement in the market with only limited trading seen in the benchmark series. Market has only started to be busy in the second session triggered by selling interest into selected series including the 5Y FR86/10Y FR87 that got traded down to 101.4 (5.12%) and 101.35 (6.3%) respectively. Overall the yield closed the day higher by around 1 – 2 bps compared to lasyt Friday's closing.




