DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI slightly weakened and closed at 6,994 (-32 points or -0.46%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR -722bn today and rupiah slightly weakened to IDR 15,313/USD.

Banking stocks were mixed as BBCA (+1.22%) and BDMN (+8.52%) rose, while MEGA (-1.82%), BMRI (-1.33%), and BBRI (-1.58%) weakened. Consumer names were mixed as KLBF (+2.71%), INDF (+0.82%), and ICBP (+0.56%) up, while SIDO (-1.4%) and UNVR (-0.83%) closed lower. Mining stocks were negative as ANTM (-1.29%), INCO (-1.84%), PTBA (-3.26%), ITMG (-4.34%), and ADRO (-5.31%) all down. Infra names were mostly positive as TOWR (+2.92%), PGAS (+3.99%), and JSMR (+0.3%) all up, except TBIG (-1.1%). Other movers were MEDC (+5.32%), PNLF (+5.13%), BIPI (-6.04%), and BUMI (-5.38%).

Ministry of Industry noted that currently there are 82 nickel smelters under construction. Investment in nickel smelters is predicted to increase in the coming year, which can support downstreaming that is currently being promoted by the government.


THIN TRADING

IDR bonds traded lower today on relatively thin trading volume post stronger than expected NFP print. Bond prices opened lower with wide spread, but traded within range throughout the day. Overall tone was quiet, probably due to US market holiday as well. Market players were seen reluctant to take firm position in this lackluster market. Total foreign ownership dropped to IDR 722.94tn on Oct 5, 2022 from previously IDR 730.26tn on Sept 30, 2022. Total


