INDONESIA MARKET WRAP

EQUITY MARKET

Dragged Higher

JCI slightly strengthened and closed at 6,722 (+28 points or +0.42%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 660Bn today and rupiah slightly weakened to IDR 14,865/USD.

Banking stocks were mixed as BBKA (+0.55%), BBNI (+0.81%), and PNB (+1.75%) inched higher, while BMRI (-0.49%) and BBRI (-0.46%) closed lower. Consumer names were mostly positive as UNVR (+1.32%), KLBF (+0.49%), GGRM (+1.82%), and INDF (+0.34%) all closed higher, except ICBP (-0.66%). Mining stocks were positive as PTBA (+4.44%), ADRO (+0.91%), ANTM (+1.01%), TINS (+4.84%), and ITMG (+1.18%) all rose. Material names were positive as BRPT (+4.23%) and TPIA (+0.49%) all up. Other movers were BBHI (+24.92%), BYAN (+10.92%), PGAS (-8.04%), and FILM (-7.4%).

Indonesia's foreign reserves came at USD139.3bn in May'23 (prev: 144.2bn). The decrease came from external debt repayments and provision for higher foreign currency liquidity.

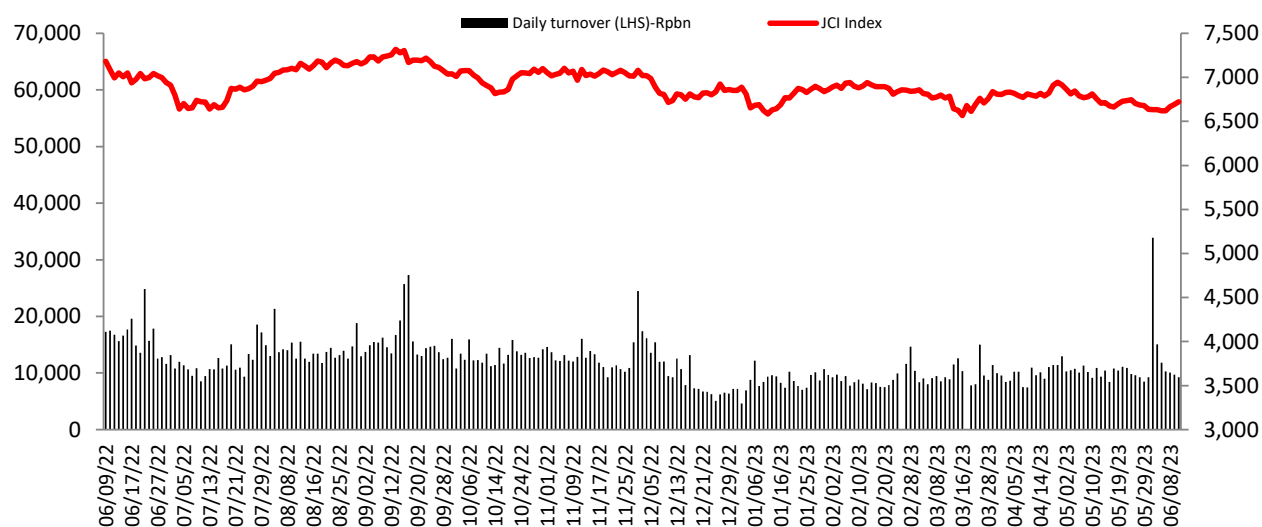
BOND MARKET

Flow Driven

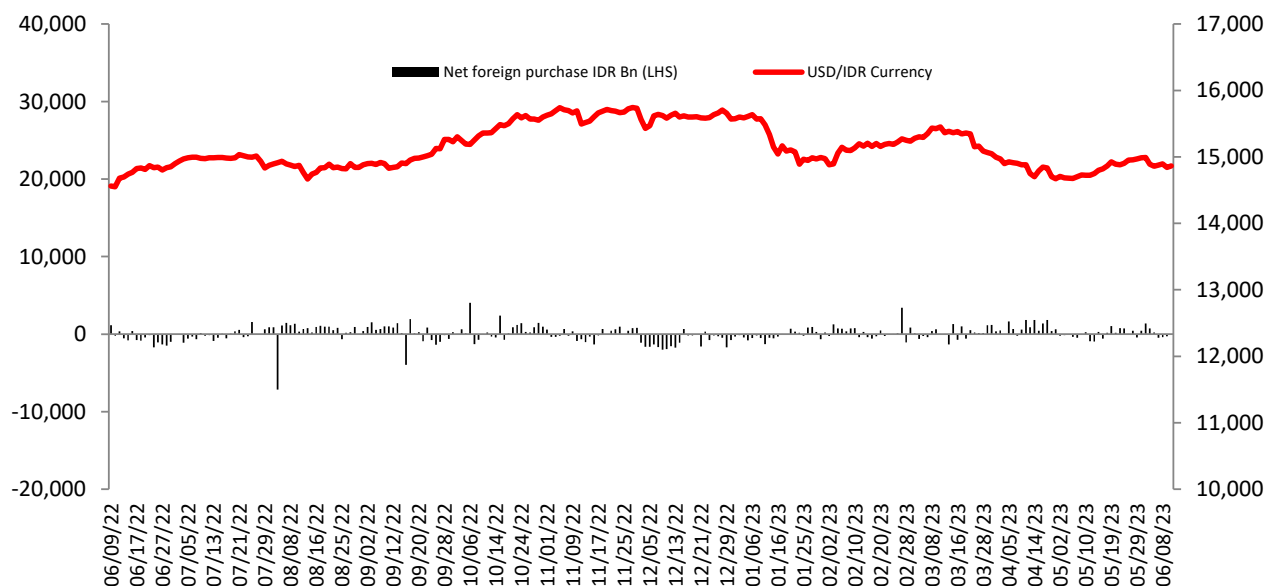
Indonesia bond market start the week with some biddish tone. Biddish tone was heard as soon as market opened. Selected buying was seen possibly from onshore foreign banks, local banks and asset managements. Biddish tone was remained thick despite auction tomorrow. Overall tone remains cautious and the yield closed the day lower by around 1 – 4 bps. There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold last conventional bond auction in this month with IDR 15Tn initial target (max upside IDR 22.5Tn), lower than previous auction. The series that will be issued are 3M SPN, 9M SPN, 5Y FR95, 10Y FR96, 15Y FR98, 20Y FR97 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 58.44Tn and DMO issued IDR 15Tn.
