DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

TUMBLED

JCI weakened and closed at 6,651 (-40 points or -0.6%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 53Bn today and rupiah slightly strengthened to IDR 14,236/USD.

Banking stocks were mostly negative as BBNI (-1.78%), BBRI (-0.71%), BMRI (-1.73%), and BBCA (-1.95%) all weakened, except MEGA (+1.8%). Consumer names were mostly positive as ICBP (+1.13%), KLBF (+1.26%), GGRM (+0.98%), and INDF (+0.4%) all in green, except UNVR (-1.29%). Construction stocks were negative as ADHI (-1.77%), PTPP (-1.19%), WIKA (-2.64%), and WSKT (-6.15%) all retreated. Pulp & paper names were negative as TKIM (-1.19%) and INKP (-1.45%) all closed lower. Other movers were BNBA (+24.78%), MTLA (+21.11%), BSIM (-6.85%), and BINA (-6.83%).

United Arab Emirates (UAE) signed an MoU for its plan to invest US\$10bn or Rp142.8tn on the development of the new capital city. All investment commitments would be realized through the Indonesia Investment Authority (INA). This investment is part of the total US\$44.6bn investment commitment from President Jokowi's recent visit to UAE.

QUIET


US Treasury yield traded higher overnight as US CPI October data came higher than expected. Despite opening with 2-5bps higher yield than yesterday closing, Indonesia bond market was relatively calm today. Only few trades were seen throughout the day with light trading volume. Although the overall market tone was mixed, no significant price action took place. At the end of the day, bond market closed with yield slightly higher by 1-2bps from yesterday level. The yield of 5/10/15/20Y benchmark closed the day at mid-yield of 5.05%/6.16%/6.22%/6.89% respectively.




