DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

REBOUNDED

JCI advanced and closed at 6,692 (+79 points or +1.2%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 494Bn today and rupiah was stabilized at IDR 15,345/USD.

Banking stocks were positive as BMRI (+5%), BBCA (+1.19%), BBNI (+2.5%), BBRI (+0.41%), and MEGA (+0.5%) all in green. Consumer names were mixed as KLBF (+1.84%), UNVR (+0.96%), and ICBP (+0.78%) closed higher, while GGRM (-2.3%) and INDF (-1.21%) corrected. Telco stocks were positive as TLKM (+3.26%), EXCL (+7.89%), and FREN (+1.75%) all closed higher. Material names were positive as BRPT (+3.25%) and TPIA (+0.9%) all inched higher. Other movers were ARTO (+9.81%), INKP (+3.86%), HRUM (-3.47%), and MIKA (-2.9%)."

Perry Warjiyo, Indonesia's current central bank governor, has obtained approval from key parliamentary body for his reappointment for second term (2023-2028).

BOND MARKET


WAIT AND SEE

Indonesia bond market remained subdued today as Indonesia govt bond index returned -0.01% during the day. Near term FOMC meeting, strong US inflation and jobs data, and concern on global banking resiliency resulted in weaker risk appetite in Indo bond market, with market moving sideways during the week. The benchmark series of 5Y/10Y/15Y/20Y closed mid yield 6.49%/6.90%/7.10%/7.13%. Today, Indonesia Debt Management Office ("DMO") held sukuk bond auction which gathers around IDR 23,51 Tn of bid from the market, in which was awarded IDR 11 Tn by Government.


