DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIGHT REBOUND

JCI advanced and closed at 6,584 (+76 points or +1.17%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 90Bn today and rupiah slightly weakened to IDR 14,378/USD.

Banking stocks were positive as BBCA (+2.74%), BBRI (+2.94%), BMRI (+1.77%), BBNI (+2.63%), and MEGA (+0.9%) all closed higher. Consumer names were mixed as GGRM (+2.7%), KLBF (+1.57%), and HMSP (+1.01%) in green, while UNVR (-0.46%) and ICBP (-0.84%) retreated. Mining stocks were positive as ADRO (+3.13%), ANTM (+3.08%), PTBA (+5.38%), ITMG (+4.67%), and INCO (+2.13%) all closed higher. Telco names were positive as TLKM (+1.96%), FREN (+3.49%), and EXCL (+2.61%) all advanced. Other movers were UNTR (+5.45%), ASII (+3.54%), POLL (-6.99%), and BBYB (-6.93%).

Gov't targets to complete the revision for the jobs omnibus law in early 2022. Note that the supreme court allows 2 years for revision period, after it enacted that the law was conditionally unconstitutional on Nov-21.




