DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,915 (+5 points or +0.07%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 1.2Tn today and rupiah slightly weakened to IDR 15,340/USD.

Banking stocks were mostly negative as BBNI (-1.09%), BBCA (-0.53%), BBRI (-1.33%), and BMRI (-2.52%) all corrected, except PNBN (+0.74%). Consumer names were mixed as MYOR (+1.92%) and ICBP (+0.66%) up, while HMSP (-0.56%), GGRM (-0.7%), and INDF (-0.71%) closed lower. Properties stocks were positive as CTRA (+3.18%), SMRA (+2.26%), BSDE (+1.29%), and LPKR (+1.92%) all in green. Pulp & paper names were positive as TKIM (+3.51%) and INKP (+1.26%) all rose. Other movers were PANI (+8.37%), PGAS (+5.04%), STTP (-5.45%), and MCAS (-4.18%).

The Ministry of Energy and Mineral Resources revealed that electric motor batteries in the motor conversion program get a warranty for 3 years. Likewise, the motor dynamo has a warranty for 1 year. There has been about 4,500 people have registered for the conversion program.


SUKUK AUCTION

Typically ahead of bonds auction, nothing much happened. No significant trades spotted today. However, in the afternoon session after London opened, Bond price traded slightly lower as UST yield rose again to 4.20%. 10Y FR96 traded lower and closed at 6.43%. In today sukuk auction, MoF released the incoming bids data which amounts to IDR 20.18Tn, MoF managed to issued to IDR 6Tn. The series absorbed (against incoming bids) on the auction were IDR 1.8Tn (IDR 3.1Tn) 6mo SPNS, IDR 3.5Tn (IDR 11.61Tn) 2Y PBS36, IDR 0.1Tn (IDR 1.63Tn) 4Y PBS3, IDR 0.2Tn (IDR 1.79Tn) 13Y PBS37, IDR 0.3Tn (IDR 1.46Tn) 16Y PBS34 and IDR 0.1Tn (IDR 0.59Tn) 24Y PBS33 at cut off yields of 4.91%, 6.02%, 5.9%, 6.48%, 6.58% and 6.65% respectively.


