DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Choppy

JCI slightly strengthened and closed at 6,808 (+11 points or +0.17%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 545Bn today and rupiah slightly strengthened to IDR 15.078/USD.

Banking stocks were mixed as BBCA (+1.66%), BBRI (+0.46%), and BMRI (+0.47%) closed higher, while BBNI (-0.28%) and PNBN (-5.38%) down. Consumer names were mixed as INDF (+1.37%) and ICBP (+1.08%) inched higher, while GGRM (-1.43%), UNVR (-0.94%), and KLBF (-1.48%) retreated. Properties stocks were positive as CTRA (+1.87%), LPKR (+3%), PWON (+1.24%), and BSDE (+0.91%) all rose. Mining names were negative as ANTM (-0.5%), INCO (-0.78%), PTBA (-1.09%), ITMG (-1.56%), and ADRO (-2.47%) all retreated. Other movers were BGTG (+15.66%), SMSM (+4.75%), BBHI (-5.26%), and SILO (-4.5%).

Realization of cigarette excise revenue is still declining nationally, MoF noted that revenues from cigarette excise at the end of May 2023 reached Rp89.95tn (-12.5% YoY).

BOND MARKET


FLATTISH

The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Ahead of the highly anticipated US CPI data tonight, bond prices continued to trade range bound and concentrated on 5Y-10Y areas. Yield wise, there is no significant movement and yield managed to close the day lower around 1 to 3bps compare to yesterday's closing level. Thin trading volume during the day pushed bidders to be more defensive with Rupiah strengthening against USD throughout the day.


