# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **FLAT**

JCI was flat and closed at 6,106 (+5 points or +0.08%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR 242Bn today and rupiah was stabilized at IDR 14,483/USD.

Banking stocks were negative as BDMN (-2.24%), MEGA (-1.57%), BBCA (-0.5%), BBRI (-1.03%), and BMRI (-2.93%) all weakened. Consumer names were mixed as MYOR (+2.68%) and ICBP (+0.87%) up, while GGRM (-1.46%), HMSP (-1.33%), and UNVR (-2.08%) closed lower. Pulp & paper stocks were negative as TKIM (-3.18%) and INKP (-3.26%) all weakened. Telco names were positive as TLKM (+0.63%), FREN (+2.54%), and ISAT (+1.68%) all closed higher. Other movers were TOWR (+19.55%), AGRO (+10.04%), MAYA (-6.88%), and SILO (-5.6%).

The gov't to give fiscal incentives in the form of VAT exemption for tenants' rental in shopping centers/malls for July to August tax period, as the social restriction (PPKM) is extended to 2 August 2021. The regulation is currently still being drafted. In addition, the gov't also plan to give fiscal incentives to other sectors like transport, hotels and restaurants.

## **BOND MARKET**


#### **SLOW DAY**

Bond market opened the week softer and bidders were on defensive mode. Overall market was relatively quiet with small trades on benchmark series. There is not much activity both from local and foreign players. By the end of day yield curve closed slightly lower by 1 – 3 bps. Tomorrow on July 27th MoF will hold regular Sukuk auction of 6M SPNS, 3Y PBS-031 as new issuance, 5Y PBS-032, 7Y PBS-030, 13Y PBS-029 and 25Y PBS-028 with indicative target of IDR 12Tn.


