DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

HIGHEST SINCE THE 1ST COVID CASE

JCI advanced to the highest level before the 1st covid case was recorded in early Mar 2020 and closed at intraday high 5,814 (+89 points or +1.56%) today. Shares across regional markets were mixed after US president-elect Joe Biden told New York Times he won't soon remove tariffs on Chinese goods. Meanwhile, foreign investors recorded net outflow of IDR 155Bn today and rupiah was stabilized at IDR 14,125/USD.

Banking stocks were positive as BBRI (+1.42%), BBCA (+0.86%), BMRI (+1.92%), BBNI (+1.6%), and BDMN (+2.15%) all rose. Consumer names were mostly positive as HMSP (+5.75%), GGRM (+3.55%), KAEF (+8.13%), and MYOR (+1.64%) all up, except UNVR (-0.65%). Mining stocks were positive as INCO (+5.16%), ANTM (+7.79%), ITMG (+7.79%), TINS (+6.07%), and PTBA (+0.82%) all jumped. Construction names were positive as WIKA (+10.75%), WSKT (+6.07%), PTPP (+8.96%), and ADHI (+5.73%) all in green. Other movers were UNTR (+7.55%), BRPT (+3.23%), CLAY (-6.71%), and NATO (-6.4%).

Indonesia inflation in November was recorded at 0.28% MoM or 1.59% YoY, higher compared to the October figure of 0.07% MoM or 1.44% YoY. In YTD, the inflation was recorded at 1.23%.

BOND MARKET


QUIET

It was a quiet trading for bond market today with prices move in a tight range. There was no trace of yesterday massive auction demand in the market as investors were comfortable stay sidelined lacking of any news to move the market. From our side we heard 15Y FR80 traded up to 108.2 (6.61%) in the first session, while in the second session bond market was pretty much mute. Yield curve closed lower by 1-4bps.


