INDONESIA MARKET WRAP

EQUITY MARKET

SOLD OFF

JCI weakened and closed at 6,229 (-58 points or -0.92%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net outflow of IDR - 10.5Tn today and rupiah was stabilized at IDR 14,308/USD.

Banking stocks were mixed as BBRI (+1.3%) and BBTN (+4.58%) closed higher, while BBNI (-0.47%), BMRI (-0.81%), and BBKA (-3.43%) corrected. Consumer names were negative as GGRM (-1.54%), INDF (-1.57%), HMSP (-0.97%), KLBF (-2.1%), and UNVR (-2.28%) all declined. Telco stocks were negative as FREN (-4.46%), ISAT (-5.64%), and TLKM (-0.81%) all closed lower. Poultry names were negative as MAIN (-3.13%), JPFA (-4.3%), and CPIN (-2.72%) all corrected. Other movers were DSSA (+17.14%), SMBR (+14.39%), BYAN (-6.96%), and MASA (-6.95%).

Gov't is preparing for 700MHz frequency auction to support the 5G ecosystem development. Ministry of Communication and IT also noted that there is possibility of 3.5GHz spectrum to be auctioned.

BOND MARKET

CLOSED THE WEEK SLIGHTLY HIGHER

Indonesia bond market opened the day firmer in line with lower UST yield overnight. Rally was seen as soon as the market opened with 10Y FR87 traded to as high as 101.4 (6.29). Unfortunately the rally did not sustain as profit takers came in and bidders shied away from the market. Overall yield curve closed lower around 1-4 bps compared to yesterday closing, save for 20Y FR83 which closed higher by 3bps due to strong retail demand. The 5Y/10Y/15Y/20Y benchmark closed the week at mid yield of 5.19%/6.32%/6.34%/7.1%

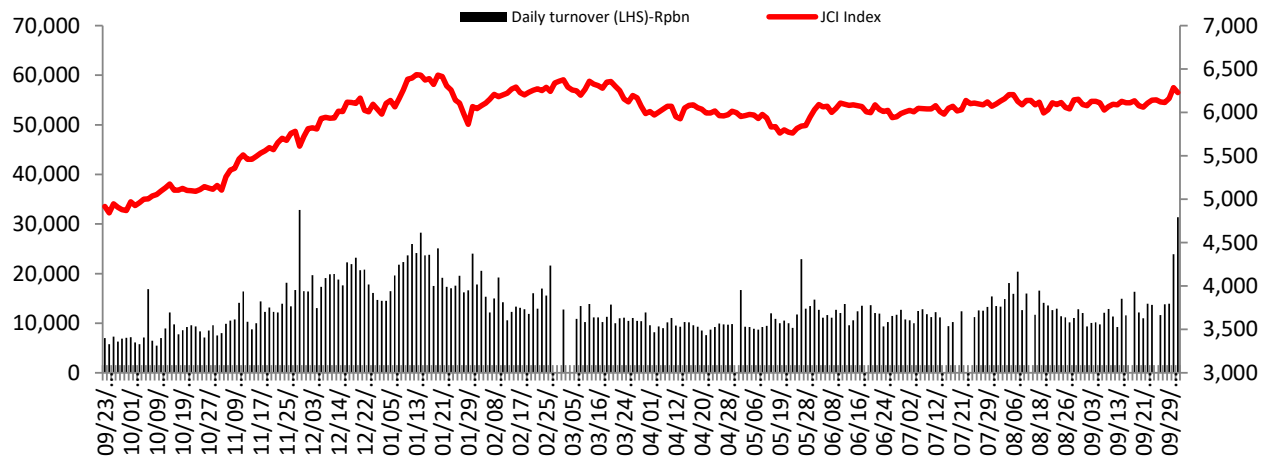

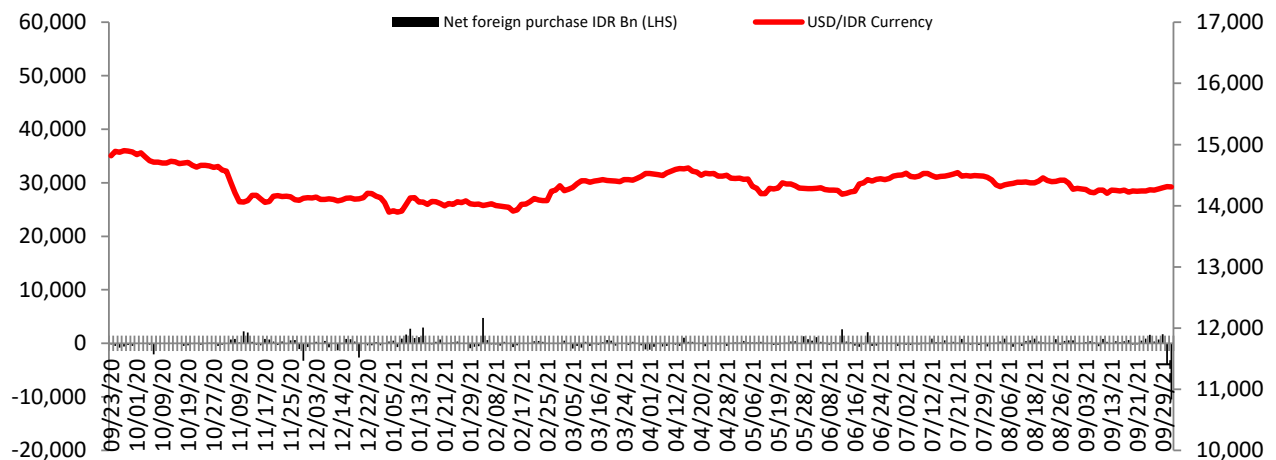
