INDONESIA MARKET WRAP

EQUITY MARKET

SOLD OFF

JCI weakened the most since mid of Apr 2020 and closed at 5,006 (-143 points or -2.78%) today. Shares across regional markets were mostly negative as risk appetite remains relatively muted with the global coronavirus infection rate accelerates to a million cases every 4 days. Meanwhile, foreign investors recorded net outflow of IDR -1.5Tn today and rupiah slightly weakened to IDR 14,630/USD.

Banking stocks were mostly negative as BBNI (-3.48%), BMRI (-5.17%), BBKA (-1.76%), and BBRI (-5.38%) all retreated, except MEGA (+17.91%). Consumer names were mostly negative as MYOR (-2.55%), GGRM (-3.3%), UNVR (-1.79%), and HMSP (-5.28%) all down, except ICBP (+1.09%). Telco stocks were negative as EXCL (-4.8%), FREN (-6.99%), and TLKM (-4.26%) all declined. Poultry names were negative as MAIN (-6.56%), JPFA (-5.66%), and CPIN (-4.82%) all down. Other movers were HRUM (+4.66%), DSNG (+4.37%), ASII (-5.24%), and UNTR (-4.22%).

Ministry of Energy and Mineral Resources projected the electricity subsidy will increase to IDR 62,9Tn in 2020, although electricity consumption is decreased by -6.25%. Previously the allocated subsidy was IDR 54,8Tn in state budget.

BOND MARKET

SLIGHTLY LOWER

IDR bond opened unchanged today compared to Thursday's closing. Only few trades were seen throughout the day. We heard selling interest which was initiated by offshore names although most trading was concentrated in the front to belly curve. Weakening sentiment in bond market was aligned with that in USD/IDR as the pair closed higher at 14,770 level. In the middle of the day, Government announced CPI data came out today and MoM it printed a deflation of -0.10% and CPI YoY printed 1.54% (expected 1.71%). Overall the yield closed the day higher by around 3 – 6 bps.




