## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### Higher Again

JCI advanced and closed at 6,879 (+90 points or +1.33%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 269Bn today and rupiah advanced to IDR 15,538/USD.

Banking stocks were positive as BBRI (+1.96%), BBKA (+1.69%), BMRI (+1.72%), BBNI (+1.64%), and MEGA (+0.47%) all up. Consumer names were mostly positive as KLBF (+1.57%), UNVR (+1.97%), ICBP (+0.24%), and KAEF (+12.86%) all in green, except INDF (-0.39%). Mining stocks were positive as ADRO (+1.61%), ANTM (+2.72%), INDY (+3.13%), TINS (+4.55%), and ITMG (+0.79%) all rose. Cement names were mostly positive as SMGR (+4.44%), INTG (+4.53%), and SMBR (+3.23%) all advanced, except SMCB (-3.94%). Other movers were ARTO (+8.06%), BRPT (+3.37%), NATO (-24.52%), and STTP (-5.34%).

Bank Indonesia conducted another SRBI auction on 3 Nov 2023. Sales reached Rp10.1tn (+154% compared to previous auction), while bids reached Rp10.6tn (+69% compared to previous auction). Bid to cover was 1.0x. With this issuance, cumulative sales since inception (15 Sept) has reached Rp144.3tn.


### BOND MARKET

#### POSITIVE SENTIMENT


Indonesia bond market started the week with lower yield around 10 – 15 bps on the back of 10Y UST yield touched 4.57% after US NFP announcement last Friday. Buying interest from mixed players remains thick in the air especially on 10Y areas. We did see some profit takers came in to the market in the second session, however the sentiment still positive throughout the day. On the data front, Indonesia Q3 GDP YoY printed at 4.94% slightly lower than what market expected it would be at 5.00%. The yield curve closed lower with benchmark series of 5Y/10Y/15Y/20Y closed at mid-yield 6.59%/6.65%/6.84%/6.96%.
