ESG integration

Exclusion: Critical controversies check and ESG screenings (i.e. energy transition score below 30%).

Integration: ESG score of each company impacts its expected return & allocation.

Guarantee: ESG characteristics to be better than investment universe.



Optimization process

Implemented at the end to maximize the exposure to the Value Factor under constraints such as the maximum volatility of alpha below 4%



INVESTMENT GUIDELINES

1. Investment Objective

Replicate the performance of the BNP Paribas Value Europe ESG Index (Bloomberg: BNPIFEVE Index), including fluctuations, and to maintain the
Tracking Error between the sub-fund and the index below 1%.

2. Benchmark

- The benchmark is the BNP Paribas Value Europe ESG Index, published in EUR. The composition of the index is reviewed on a monthly basis.
 The index is valued daily. BNP Paribas Value Europe ESG Index measures the performance of European companies that appear underpriced using a fundamental analysis.

3. Investment Guidelines¹

- Long-only equity fund
- The strategy is implemented through a synthetic replication of the index. Exposure to the index is achieved by entering into a swap that enables the sub-fund to convert the exposure of its 'substitute basket' to the exposure to the index
- The sub-fund will not invest more than 10% of its net assets in shares or units issued by UCITS or other UCIs


