INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,044 (-3 points or -0.05%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 189Bn today and rupiah was stabilized at IDR 14,483/USD.

Banking stocks were mixed as MEGA (+2.24%), BBKA (+0.17%), and BBNI (+0.42%) advanced, while BMRI (-0.43%) and BBRI (-1.8%) corrected. Consumer names were mostly negative as HMSP (-0.43%), KLBF (-1.09%), GGRM (-1.39%), and UNVR (-1.4%) all declined, except ICBP (+0.6%). Mining stocks were negative as TINS (-2.85%), ITMG (-2.26%), ANTM (-0.81%), PTBA (-2.33%), and ADRO (-3.1%) all retreated. Infra names were negative as PGAS (-0.96%), JSRM (-1.45%), TOWR (-1.12%), and TBIG (-2.37%) all declined. Other movers were AGRS (+34.13%), SRAJ (+24.41%), BBHI (-6.8%), and MDKA (-3.83%).

Bank Indonesia (BI) is optimistic that the growth of e-commerce transactions in 2021 will exceed the previous forecast to 39.1% YoY (vs. 33.2% YoY) with a value of Rp370tn.

BOND MARKET

COLLECTING NEW SERIES

Indonesia bond market starts the day with firmer tone following UST rally last night. Unabsorbed bidder tried to collect new benchmark series in secondary market especially on 11Y FR91 and 21Y FR92. The 11Y FR91 and 21Y FR92 got traded to as high as 99 (6.50%) and 101 (7.03%), which yield wise is lower by 13 and 29 bps than yesterday's auction cut off at 6.63% and 7.32%. Buying activities for new benchmark series were mostly driven by local names. The 5Y/10Y/15Y/20Y benchmark closed the day at mid yield of 5.35%/6.51%/6.38%/7.20%.

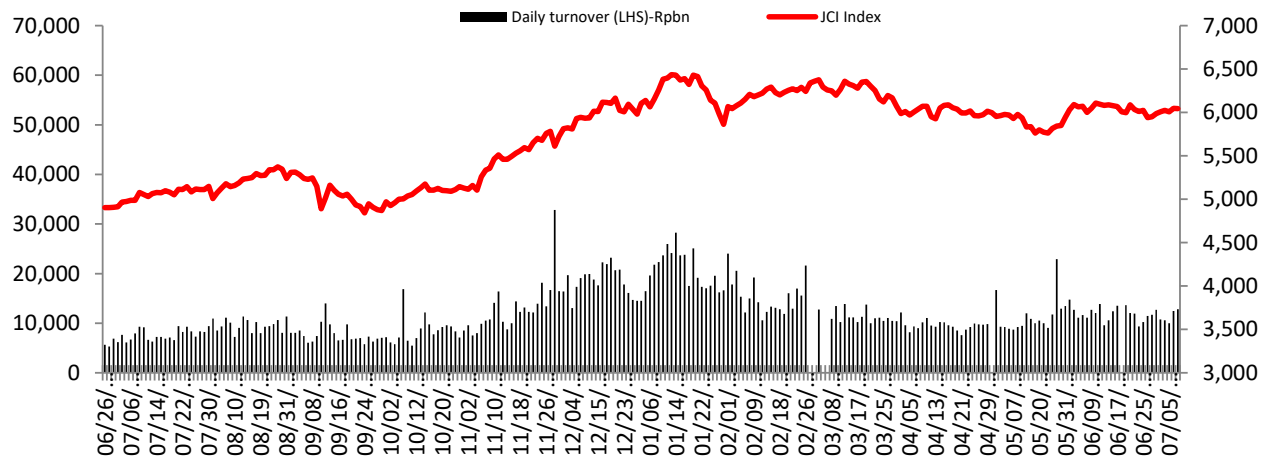

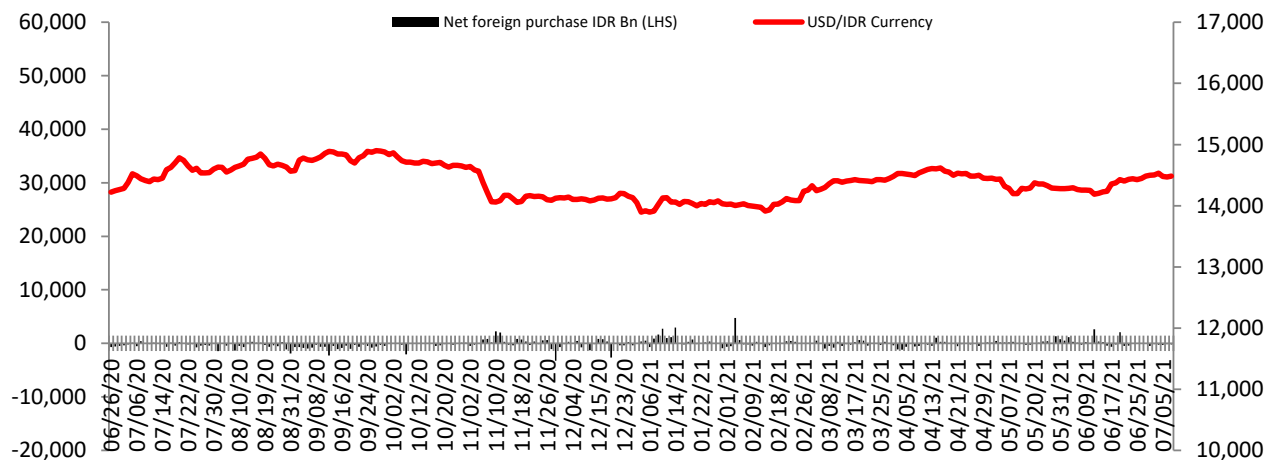
