DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI slightly weakened and closed at 6,089 (-9 points or -0.14%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 330Bn today and rupiah was stabilized at IDR 14,488/USD.

Banking stocks were mostly negative as PNBN (-2.6%), BBNI (-1.29%), BBCA (-0.42%), and BBRI (-1.84%) all corrected, except BMRI (+1.29%). Consumer names were mostly negative as GGRM (-1.44%), KLBF (-1.87%), HMSP (-1.36%), and UNVR (-1.11%) all closed lower, except SIDO (+5.88%). Telco stocks were negative as FREN (-1.63%), ISAT (-3.8%), and TLKM (-2.45%) all closed lower. Construction names were negative as ADHI (-4.73%), WIKA (-3.05%), PTPP (-5.03%), and WSKT (-6.7%) all corrected. Other movers were SDRA (+25%), MMLP (+16.26%), MAYA (-6.71%), and MASA (-6.62%).

The Ministry of Investment noted that investment realization reached Rp223 tn (+16.2% YoY) in 2Q21. In detail, the realization of domestic investment is Rp106.2 tn. Meanwhile, foreign investment reached Rp116.8 tn.

BOND MARKET


FLATTISH

The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. Bond prices continued to trade range bound and concentrated on 5Y - 10Y areas. Yield wise, there is no significant movement and yield managed to close the day lower around 1 to 3bps compare to yesterday's closing level. Offer level in the market for benchmark series of 5Y/10Y/15Y/20Y was at 5.16%/6.28%/6.28%/7.04%.


