# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

## **FLAT**

JCI closed flat today at 6,416 (-0.927 points or -0.01%). Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1.6Tn today and rupiah was stabilized at IDR 14,215/USD.

Coal stocks corrected following huge correction in NEWC coal prices the night before with PTBA (-5.63%), ITMG (-6.92%), and ADRO (-6.97%). Banks were mixed with BMRI (+1.52%) up, BBRI flat, while BBNI (-0.42%) and BBCA (-0.28%) down. Laggard names within staples and tobacco staged a strong gain with UNVR (+13.11%), MYOR (+3.86%), GGRM (+5.14%), HMSP (+4.65%) and WIIM (+7.77%). Digital banks were mixed as AGRO (-2.80%) and BBYB (-3.33%) down while BACA (+3.68%), BBHI (+4.09%) and BINA (+3.56%) up. OTher movers were PGAS (+2.77%), ACES (+2.84%) and FREN (+1.01%).

The foreign exchange reserves at the end of September are estimated at around US\$ 143 billion to US\$ 144 billion. The trend of increasing foreign exchange reserves since last June is not predicted to continue. This foreign exchange reserve is sufficient to anticipate risks arising from the Fed's liquidity reduction policy that threatens the rupiah exchange rate.

### TWO WAY INTEREST


The mixed sentiment continued to be seen in the bond market today with the bond price opened around the same level as yesterday's closing. Bond price movement was within range as the market showed two way interests throughout the day. The benchmark series remain as market's favorite while The longer tenor was unchanged. Overall the curved moved down by 1 - 2 bps. Offer level in the market for benchmark series of 5Y/10Y/15Y/20Y was at 5.15%/6.31%/6.84%/7.118%.




