INDONESIA MARKET WRAP

EQUITY MARKET

Lower

JCI slightly weakened and closed at 6,700 (-19 points or -0.29%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 703Bn today and rupiah slightly weakened to IDR 14,900/USD.

Banking stocks were mostly negative as BBTN (-0.79%), BBNI (-1.64%), BMRI (-0.98%), and BBKA (-0.82%) all corrected, except MEGA (+0.2%). Consumer names were mostly negative as GGRM (-1.43%), HMSP (-1.51%), UNVR (-1.55%), and KLBF (-1.44%) all down, except INDF (+1.02%). Pulp & paper stocks were positive as INKP (+6.14%) and TKIM (+3.78%) all up. Telco names were negative as FREN (-1.64%), EXCL (-1.95%), and TLKM (-0.74%) all declined. Other movers were DEWA (+22%), ESSA (+7.83%), SILO (-7.98%), and MAPA (-3.38%).

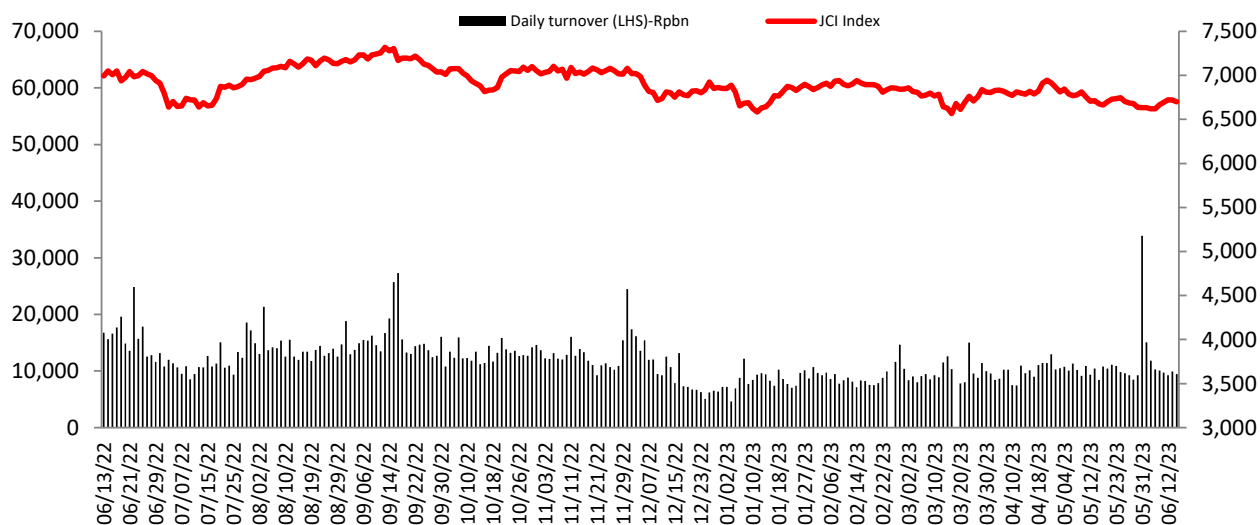
BOND MARKET

FLATTISH

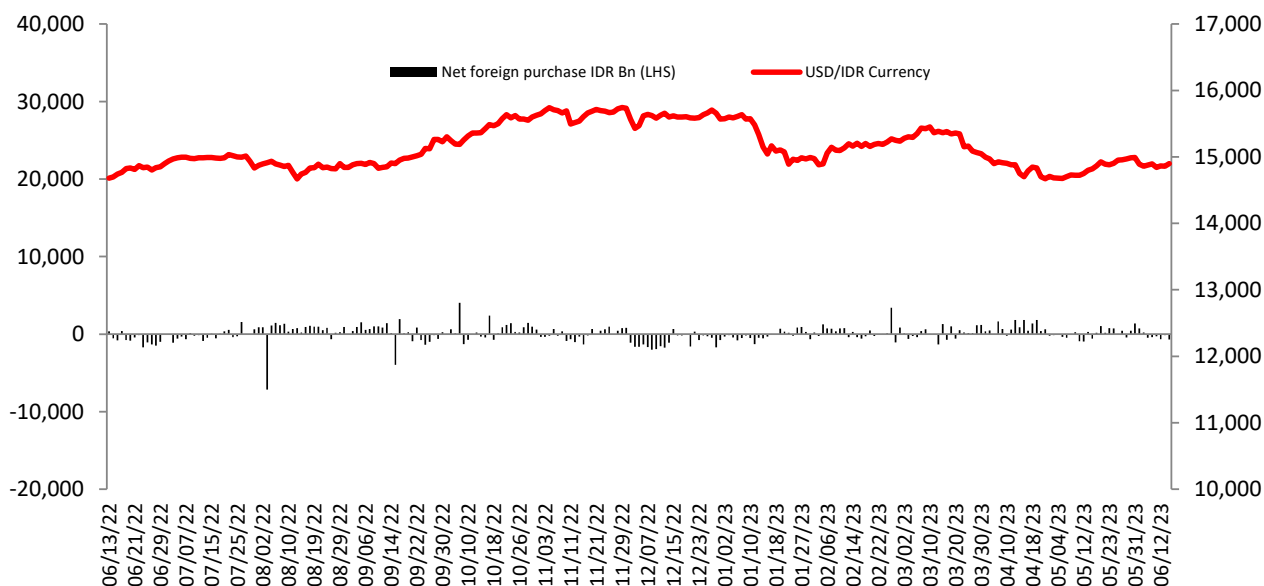
The bond market saw no improvement in risk sentiment today although we witnessed two ways trading in the market. We heard buying interest started by onshore players due to short covering interest amid shortage of auction supply. While the offshore players acted as profit takers although trading volume remained thin. Thin trading volume during the day pushed bidders to be more defensive. Price movement went back to range bound lacking fresh catalyst. Overall, yield movement for today -4/0/-1/-1 bps for 5/10/15/20yr tenor.
