DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

WEAKENED

JCI weakened and closed at 6,547 (-55 points or -0.83%) today. Shares across regional markets were negative. Meanwhile, foreign investors recorded net inflow of IDR 544Bn today and rupiah was stabilized at IDR 14,378/USD.

Banking stocks were mostly negative as BDMN (-1.65%), BBNI (-0.37%), BMRI (-1.05%), and BBCA (-1.67%) all weakened, except BBRI (+0.24%). Consumer names were negative as SIDO (-1.14%), UNVR (-0.24%), MYOR (-0.99%), INDF (-1.54%), and HMSP (-1.02%) all weakened. Mining stocks were negative as INCO (-0.86%), INDY (-6.02%), ITMG (-3.14%), ANTM (-1.33%), and PTBA (-2.93%) all corrected. Material names were negative as BRPT (-1.12%) and TPIA (-3.38%) all down. Other movers were APEX (+24.62%), MPRO (+9.58%), MASA (-6.87%), and BBHI (-5.19%).

The DKI Jakarta Provincial Government has decided to increase the 2022 Provincial Minimum Wage by IDR 225,667 or 5.1% from the 2021 UMP to IDR 4,641,854.

WITHIN RANGE


The mixed sentiment continued to be seen in the bond market today with the bond price opened around the same level as last Friday's closing. We witnessed several sporadic activity although the volume was very limited. Overall, yield somewhere 1-3bps tighter across tenors, but IDR bonds still traded within range. Investors closely watching UST movement amid rising omicron concerns. The benchmark of 5Y, 10Y, 15Y and 20Y closed at mid yields of 5.16%, 6.39%, 6.26% and 7.05% respectively. Spot closed at 14,402.




