### OBJECTIVE

The objective of the fund is to provide capital growth over the medium term and to offset its carbon footprint (Scope 1 and 2)<sup>1</sup>. It is exposed to the performance of a dynamic basket of European Investment Grade Corporate Bonds, which are chosen using a systematic selection method based on Environmental, Social and Governance criteria (ESG) as well as a carbon emission and energy transition criteria.

The carbon footprint of the portfolio aims to be offset every quarter through the purchase of Verified Emission Reduction certificates (VERs) from the Kasigau Corridor REDD+<sup>2</sup> project in Kenya.
