DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

ADVANCED

JCI advanced and closed at 6,110 (+79 points or +1.31%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 2Bn today and rupiah slightly strengthened to IDR 14,413/USD.

Banking stocks were mixed as BBRI (+0.76%), BMRI (+1.27%), and PNBN (+3.31%) advanced, while BBCA (-0.15%) and BBNI (-1.38%) retreated. Consumer names were positive as GGRM (+4.87%), HMSP (+2.09%), MYOR (+1.86%), ICBP (+0.92%), and KAEF (+5.65%) all closed higher. Infra stocks were positive as TOWR (+3.86%), PGAS (+5.5%), TBIG (+0.94%), and JSMR (+1.26%) all up. Telco names were positive as TLKM (+1.18%), FREN (+6.4%), and EXCL (+1.11%) all advanced. Other movers were BBYB (+24.91%), MASA (+24.88%), AMRT (-6.98%), and BOLA (-6.76%).

The government is optimistic that the 2022 economy will recover, thus setting a high target for the value added tax (VAT) next year. In the 2022 RAPBN, the government targets VAT of Rp552.3 tn, an increase of 10.1% from this year's estimated realization. VAT revenue will grow by 8-8.5% due to GDP growth and inflation, while the remaining 1.6-2.1% will come from extra government efforts.

BOND MARKET

QUIET

Indonesia bond market was calm today. Only few trades were seen throughout the day with light trading volume and prices moved in tight range. Although the overall market tone was mixed, no significant price action took place. IDR bond the prices ended the day unchanged from last Friday level. The yield of 5/10/15/20Y benchmark closed the day at mid-yield of 5.16%/6.34%/6.34%/7.04% respectively.




