DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIDE DOWN

JCI slightly strengthened and closed at 7,094 (+34 points or +0.48%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 663Bn today and rupiah slightly strengthened to IDR 15,455/USD.

Banking stocks were mixed as BBRI (+2.8%), BMRI (+1.69%), and BBNI (+0.95%) closed higher, while MEGA (-1.42%) and BBCA (-0.28%) retreated. Consumer names were mixed as SIDO (+6.43%) and INDF (+0.4%) up, while HMSP (-1.57%), MYOR (-1.59%), and KLBF (-1.5%) corrected. Retailer stocks were negative as ACES (-2.04%), MAPA (-1.84%), MAPI (-4.02%), and AMRT (-1.03%) all retreated. Mining names were positive as ANTM (+2.64%), PTBA (+1.23%), INDY (+2.02%), TINS (+2.31%), and INCO (+0.23%) all rose. Other movers were GJTL (+24.72%), MPRO (+24.65%), ARTO (-11.46%), and BBHI (-7.37%).

Bureau of statistics recorded headline inflation continued to rise to 2.86% in Nov 2023 from 2.56% in Oct 2023. Food, beverages and tobacco was the biggest contributor (60%), followed by personal care and other services (8%).

UNEVENTFUL


It was a quiet trading for bond market today. Investors were comfortable stay sidelined lacking of any news to move the market. Bond prices continued to trade range bound and still focused on benchmark series. There is no significant movement, yield managed to close the day lower around 1 to 2 bps compare to last Friday closing level. The benchmark series of 5, 10, 15 and 20Y closed at mid yield of 6.52%, 6.58%, 6.74% and 6.79%.

Tomorrow on Dec 5th MoF will hold regular Sukuk auction of the year. The series offered are 6M SPNS, 2Y PBS-036, 4Y PBS-003, 6Y PBSG-001, 13Y PBS-037, 16Y PBS34, 24Y PBS-033 and 26Y PBS38 (new issuance) with indicative target of IDR 9Tn


