INDONESIA MARKET WRAP

EQUITY MARKET

DOWN

JCI weakened and closed at 6,066 (-72 points or -1.17%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 76Bn today and rupiah slightly strengthened to IDR 13,895/USD.

Banking stocks were negative as BDMN (-0.63%), PNB (-0.85%), BBNI (-1.54%), BBRI (-1.64%), and BBKA (-2.05%) all closed lower. Consumer names were mostly negative as MYOR (-1.74%), KAEF (-5.17%), HMSP (-1.99%), and UNVR (-2.37%) all retreated, except KLBF (+2.04%). Properties stocks were negative as SMRA (-4.19%), CTRA (-2.87%), PWON (-2.86%), and BSDE (-3.52%) all retreated. Telco names were negative as ISAT (-2.24%), EXCL (-2.49%), and TLKM (-2.88%) all weakened. Other movers were MEDC (+7.87%), CITA (+3.33%), MIKA (-5.34%), and ADRO (-3.51%).

President Joko Widodo asked Health Minister Budi Gunadi Sadikin to complete the COVID-19 vaccination in less than a year. Previously, vaccinations were targeted to be completed in 15 months, which was estimated through the total target of 182 million people to be vaccinated. Jokowi himself will be the first to receive the vaccination on 13 Jan 2021.

BOND MARKET

COLLECTING NEW SERIES

Indonesia bond market start the day with biddish tone. Unabsorbed bidder tried to collect new benchmark series in secondary market especially on 15Y FR88 and 30Y FR89. The 15Y FR88 and 30Y FR89 traded with lower by 18 and 23 bps than yesterday's auction cut off at 6.44% and 6.97%. Buying activities for new benchmark series were driven by local end client. Meanwhile, in the second session, IDR bond market remained calm. The 5Y/10Y/15Y/20Y benchmark closed the day at mid yield of 5.11%/5.93%/6.27%/6.54%.

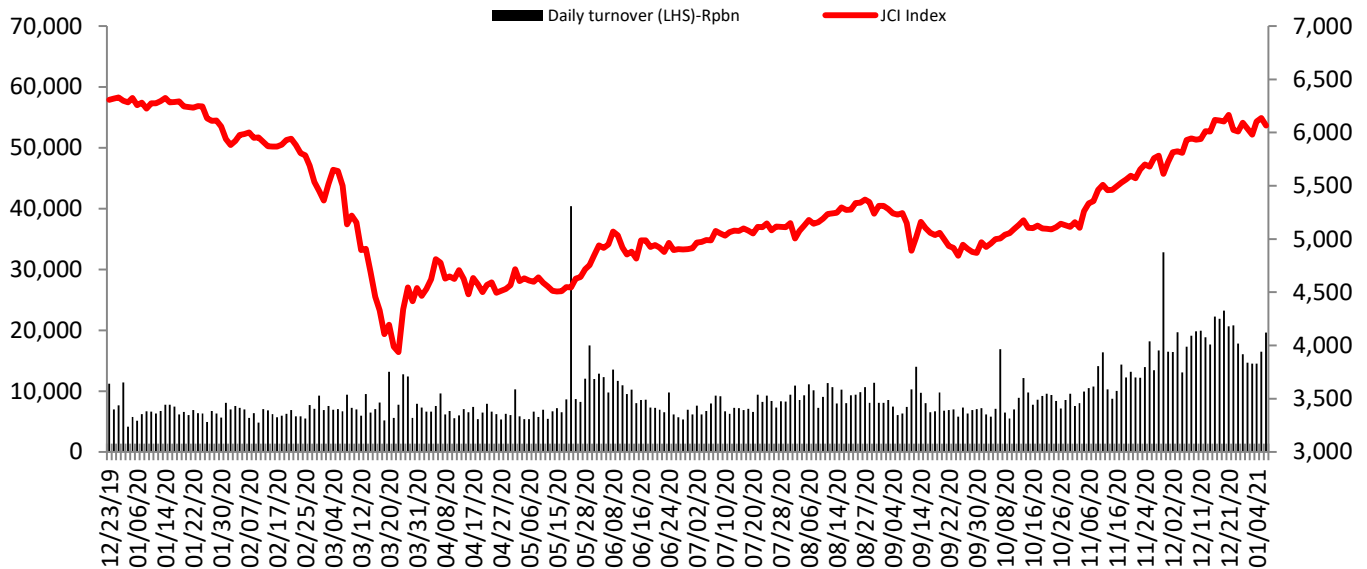

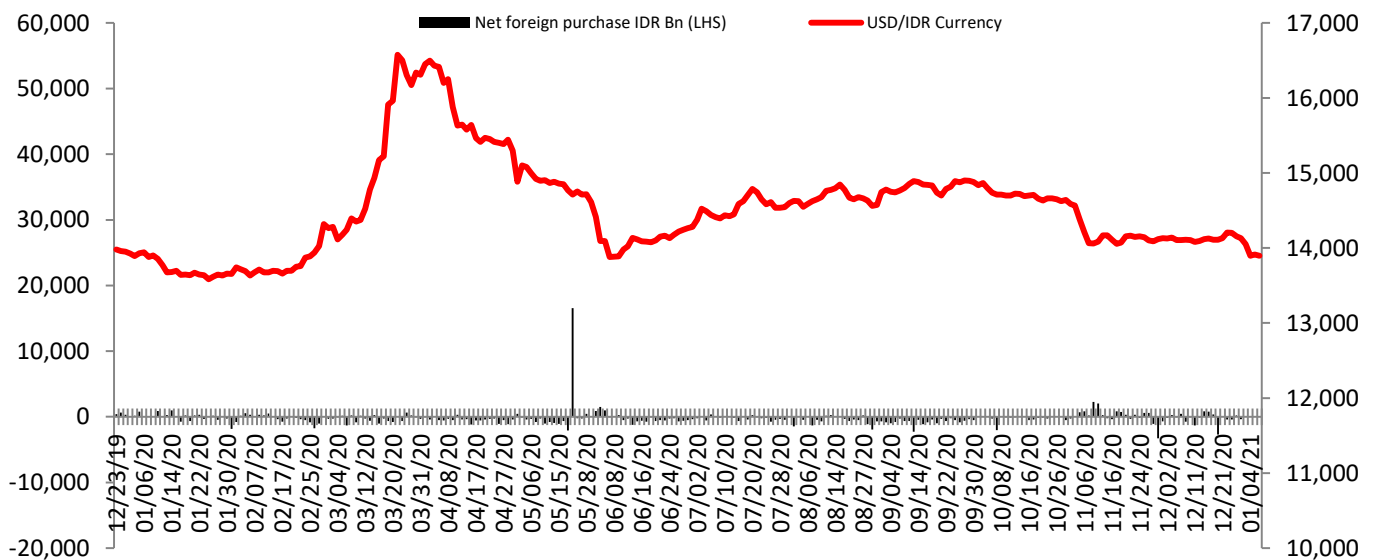
