DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 6,833 (+6 points or +0.09%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 443Bn today and rupiah slightly strengthened to IDR 14.900/USD.

Banking stocks were mostly negative as PNBN (-2.49%), MEGA (-0.5%), BBCA (-0.28%), and BMRI (-1.2%) all corrected, except BBRI (+0.42%). Consumer names were mixed as INDF (+2.83%), ICBP (+2.26%), and KLBF (+0.96%) advanced, while MYOR (-1.14%) and HMSP (-1.9%) weakened. Retailer stocks were negative as MAPA (-2.86%), ERAA (-3.85%), MAPI (-3.45%), and AMRT (-1.71%) all corrected. Material names were negative as TPIA (-1.72%) and BRPT (-3.07%) all closed lower. Other movers were BIPI (+11.56%), HRUM (+5.72%), TCPI (-5.03%), and ARTO (-4.02%).

Based on IHS Markit, Indonesia Manufacturing PMI continued to remain in expansionary level at 51.9 in Mar-23, accelerating from 51.2 in Feb-23. This marks the 19th consecutive month of growth in factory activity.

BOND MARKET

SUKUK AUCTION


Indonesia bond market closed the day lower yield around 2 – 5 bps. Mixed trading was seen with onshore players was on the sell side while onshore foreign banks and on the buy side. In today sukuk auction, government received incoming bids totaling at IDR 24.77Tn. MoF issued IDR 9Tn. The series absorbed (against incoming bids) on the auction were IDR 1.15Tn (IDR 4.05Tn) 6mo SPN-S, IDR 2.3Tn (IDR 13.25Tn) 2Y PBS36, IDR 1.45Tn (IDR 1.94Tn) 4Y PBS3, IDR 0.95Tn (IDR 1.51Tn) 13Y PBS37, IDR 2.25Tn (IDR 2.34Tn) 16Y PBS34 and IDR 0.9Tn (IDR 1.68Tn) 24Y PBS33 at cut off yields of 4.85%, 6.39%, 6.51%, 7.1%, 7.1% and 7.17% respectively.




