# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **FLAT**

JCI was flat and closed at 6,040 (0 points or 0%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 23Bn today and rupiah was stabilized at IDR 14,528/USD.

Banking stocks were mostly negative as MEGA (-1.25%), BBNI (-2.52%), BMRI (-2.12%), and BBRI (-1.81%) all corrected, except BBCA (+0.08%). Consumer names were positive as HMSP (+0.87%), UNVR (+0.62%), GGRM (+1.42%), ICBP (+0.88%), and INDF (+0.78%) all advanced. Mining stocks were positive as INCO (+4.42%), ADRO (+2.46%), ANTM (+1.57%), PTBA (+2.9%), and TINS (+1.24%) all advanced. Telco names were mixed as TLKM (+4.98%) and EXCL (+1.56%) rose, while FREN (-1.69%) closed lower. Other movers were BSIM (+25%), PRDA (+19.86%), BBHI (-48.1%), and AGRO (-6.94%).

Bukalapak raise IPO proceed target to US\$ 1bn – The previous target was US\$ 500-800mn due to strong investor demand. The company will offer up to 25% of its paid-up capital with Rp750-850/share offering price.

## **BOND MARKET**


#### **MUTED**

Indonesia bond market opened a tad lower today following the still increasing number of new Covid19 cases. Most of the morning session was muted with prices quoted lower with FR87 traded at 99.8 (6.52%). Support was seen from local names on the bid side although trading volume remained thin. Yield curve closed the day slightly higher by 1-2 bps. The benchmark series of 5Y/10Y/15Y/20Y closed at mid yield 5.37%/6.52%/6.39%/7.19% with local currency closed at 14528 today.


