INDONESIA MARKET WRAP

EQUITY MARKET

SLIDE DOWN

JCI slightly weakened and closed at 6,684 (-24 points or -0.35%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 460Bn today and rupiah slightly weakened to IDR 14,378/USD.

Banking stocks were mostly negative as BBTN (-0.6%), BBNI (-1.02%), MEGA (-2.56%), and BBKA (-0.96%) all down, except BBRI (+1.47%). Consumer names were mixed as HMSP (+1.06%) and INDF (+0.39%) rose, while UNVR (-0.99%), KLBF (-1.78%), and ICBP (-2.02%) down. Properties stocks were positive as CTRA (+6.15%), PWON (+4.17%), BSDE (+3.83%), and SMRA (+2.86%) all closed higher. Poultry names were negative as MAIN (-0.76%), JPFA (-3.6%), and CPIN (-2.45%) all declined. Other movers were ESSA (+9.32%), MEDC (+6.6%), EMTK (-4.55%), and ARTO (-4.05%).

The Central Bureau of Statistics reported that inflation reached 0.56% on Jan-22 or 2.18% on an annual basis. The increase in the price of food ingredients contributes the most to the inflation, especially chicken meat and fresh fish

BOND MARKET

UNEVENTFUL

It was a quiet trading for bond market today. Investors were comfortable stay sidelined lacking of any news to move the market. Bond prices continued to trade range bound and still focused on benchmark series. There is no significant movement, yield managed to close the day higher around 1 to 2 bps compare to yesterday's closing level. The benchmark series of 5, 10, 15 and 20Y closed at mid yield of 5.21%, 6.43%, 6.43% and 6.9%.

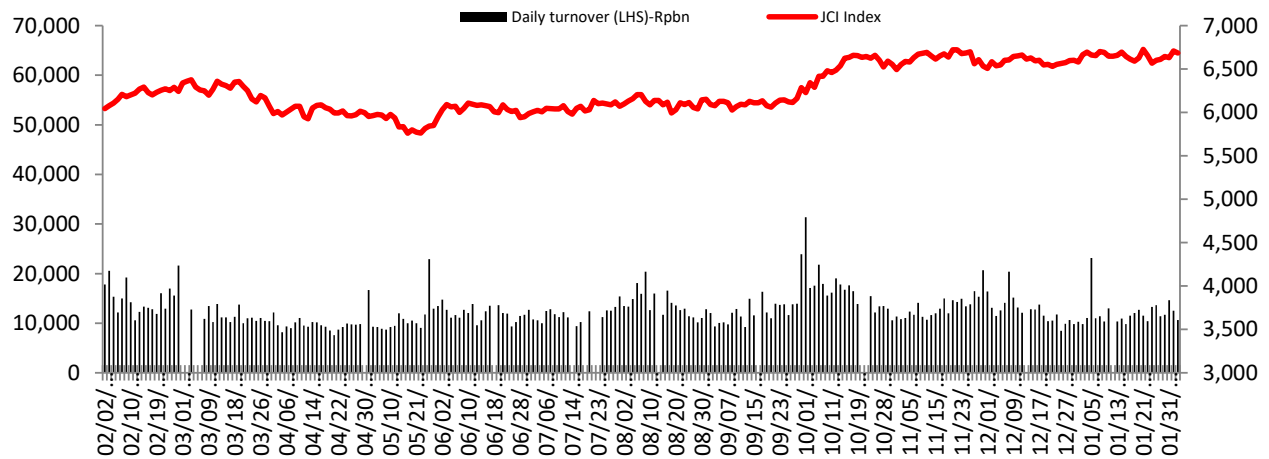

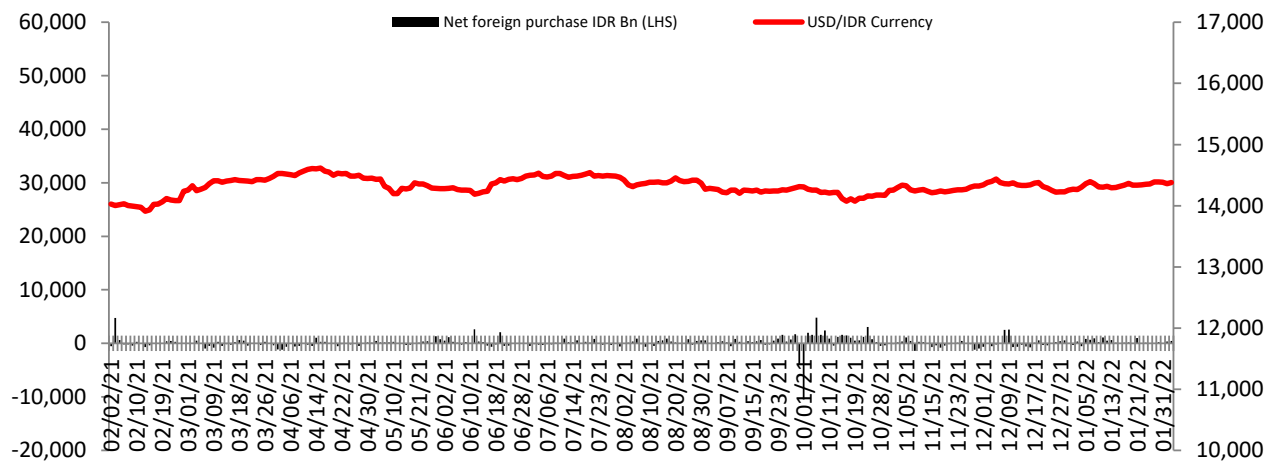
