DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

FLAT

JCI was flat and closed at 5,970 (-6 points or -0.09%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 182Bn today and rupiah advanced to IDR 14,319/USD.

Banking stocks were mostly positive as BBRI (+0.49%), BMRI (+0.41%), MEGA (+1.5%), and BBNI (+0.44%) all in green, except BDMN (-1.54%). Consumer names were mixed as KLBF (+1.04%) and INDF (+0.77%) rose, while GGRM (-0.64%), MYOR (-1.12%), and UNVR (-3.9%) declined. Material stocks were negative as BRPT (-3.08%) and TPIA (-1.81%) all corrected. Properties names were negative as CTRA (-0.88%), SMRA (-1.59%), LPKR (-2.75%), and PWON (-2.88%) all declined. Other movers were POLI (+23.89%), SUPR (+7.14%), BMAS (-6.98%), and MEDC (-3.6%).

Indo Q1 GDP growth -0.74% YoY vs est -0.65% YoY. GDP fell -0.96% QoQ vs est -0.85% QoQ. GDP growth YoY by expenditure: private consumption: -2.23%, govt spending +2.96%, gross fixed capital formation -0.235 and exports +6.74%.

FLOW DRIVEN


Indonesia bond market closed the day with better sentiment. Rupiah strengthened to 14,300 levels and UST touched 1.57%, triggered biddish tone in the bond market. Flow was mainly heard from foreign banks collecting non benchmark and benchmark series throughout the day, while local names seen on both sides. Market trading was particularly active on 10Y-20Y areas which remained as the most actively traded bonds for the day. Market closed with yields lower by 3-5 bps compared to yesterday closing level.




