

# FOR PROFESSIONAL INVESTORS - 09/23/2021 DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

### BETTER

JCI advanced and closed at 6,143 (+34 points or +0.56%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 871Bn today and rupiah was stabilized at IDR 14,243/USD.

Banking stocks were mixed as BBRI (+4.43%), BBCA (+0.38%), and BBTN (+1.1%) advanced, while PNBN (-0.67%) and BBNI (-0.49%) corrected. Consumer names were mixed as HMSP (+1.54%) and ICBP (+0.61%) closed higher, while INDF (-0.81%), MYOR (-0.82%), and KLBF (-1.76%) down. Construction stocks were positive as WIKA (+5.94%), WSKT (+1.81%), PTPP (+2.39%), and ADHI (+2.26%) all up. Properties names were negative as PWON (-0.41%), BSDE (-0.51%), CTRA (-2.69%), and SMRA (-4.12%) all closed lower. Other movers were HRUM (+19.91%), TURI (+10.29%), MCAS (-6.92%), and CMNP (-6.85%).

Outstanding P2P lending fintech financing until August 2021 grew 70.36% YoY to reach Rp26.1tn. Positive performance continues to occur even though the number of fintech lending providers continues to decrease.

# **BOND MARKET**

#### **DEBT SWITCH**


Indonesia bond market closed the day with lower yield around 3 - 5 bps amid mixed flow from market players. As soon as market opened, bonds market felt biddish led by 10Y FR87 and 11Y FR91 which got traded as high as 102.4 (6.13%) and 102.35 (6.07%). Positive sentiment might increase due to next week's lower bond auction target issuance to IDR 12 Tn from previous IDR 21 Tn. Today, MoF held Debt Switch with destination bonds FR90, FR91, FR88, FR92 and FR89 and sources bonds FR61, FR43, FR63, FR46, FR39, FR70, FR77, FR44, FR81, and FR40. However, in the afternoon session, bond market remained muted as market is still waiting for Debt Swith result.




