# DAILY REPORT INDONESIA MARKET WRAP

# **EQUITY MARKET**

#### Whipsaw

JCI slightly strengthened and closed at 7,057 (+11 points or +0.15%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 1.12Tn today and rupiah slightly weakened to IDR 14,933/USD.

Banking stocks were mixed as BBCA (+2.3%) and MEGA (+0.5%) inched higher, while PNBN (-3.55%), BBNI (-1.54%), and BBRI (-0.46%) corrected. Consumer names were positive as INDF (+1.14%), ICBP (+1.42%), GGRM (+2.29%), KLBF (+0.31%), and HMSP (+1.1%) all in green. Mining stocks were negative as TINS (-0.68%), INDY (-1.5%), ITMG (-2.11%), PTBA (-2.84%), and ADRO (-3.63%) all down. Cement names were mixed as SMGR (+4.25%), INTP (+5.77%), and SMBR (+2.98%) up, while SMCB unchanged. Other movers were EMTK (+8.05%), SCMA (+5.88%), PNLF (-6.45%), and BIPI (-6.12%).

Banggar DPR predicts that Indonesia's inflation can reach 6-6.5%, compared to 2021 levels at 1.87% in 2021.

### UNEVENTFUL




