INDONESIA MARKET WRAP

EQUITY MARKET

Higher

JCI slightly strengthened and closed at 6,961 (+22 points or +0.31%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 315Bn today and rupiah slightly weakened to IDR 15,530/USD.

Banking stocks were mixed as BBCA (+2.83%), BBRI (+0.48%), and BMRI (+0.41%) closed higher, while BBNI (-0.24%) and MEGA (-4.09%) down. Consumer names were mixed as KLBF (+1.71%), INDF (+1.89%), and GGRM (+1.02%) rose, while MYOR (-0.78%) and UNVR (-1.07%) closed lower. Material stocks were positive as BRPT (+2.31%) and TPIA (+1.58%) all advanced. Mining names were negative as ANTM (-0.55%), INDY (-2.27%), ITMG (-1.04%), INCO (-1.33%), and ADRO (-1.4%) all corrected. Other movers were MPRO (+24.86%), ISAT (+4.83%), MDKA (-7.29%), and TCPI (-4.56%).

The Industrial Confidence Index (IKI) fell by -0.71 to 52.51 in September 2023. The Ministry of Industry said the decline in IKI was due to an increase in product inventories in almost all manufacturing subsectors.

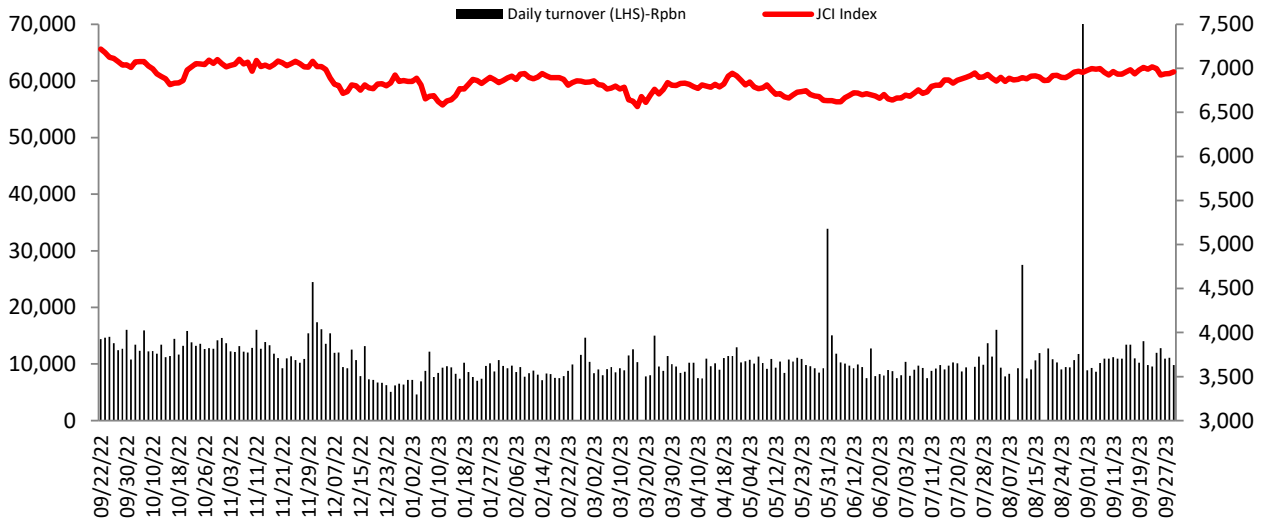
BOND MARKET

HIGHER YIELD

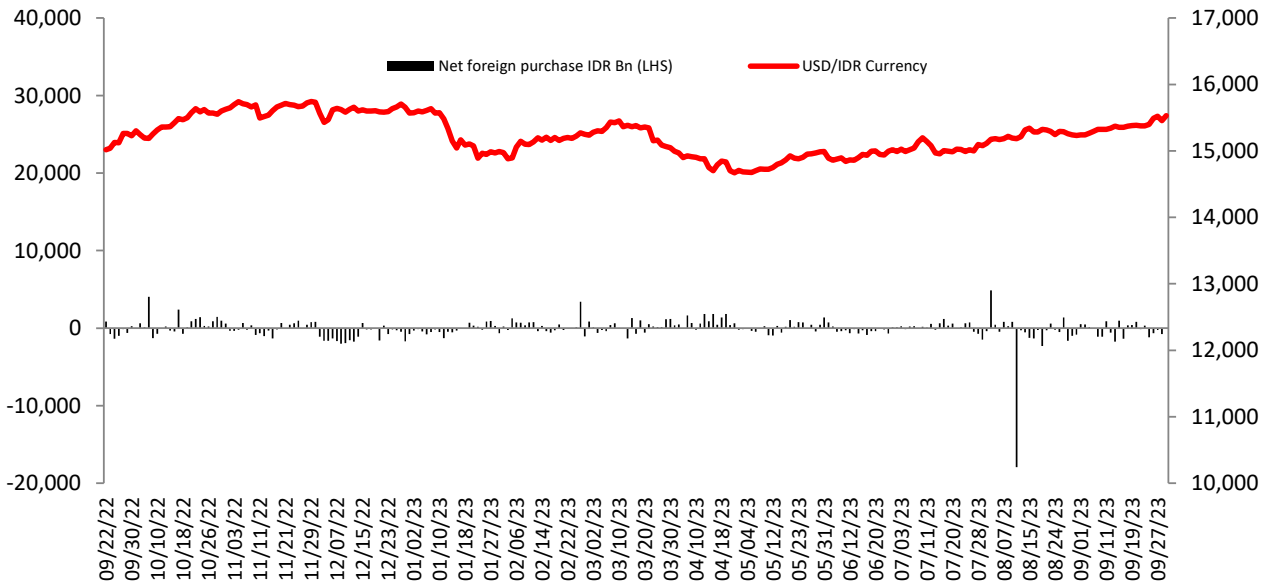
Indonesia bond market closed the day with higher yield around 5 – 9 bps followed by rupiah broke above 15,530 and UST touched at 4.60%. Ahead of tomorrow upsized auction issuance, selling pressure from interbank and foreign names remained thick in the air. Although we saw few bottom fishers came into the market, the buying failed to lend a support as prices went further south. 5Y FR95/10Y FR96/15Y FR98/20Y FR97 closed the day at mid yield of 6.62%/6.99%/7.1%/7.05%. Tomorrow, Indonesia Debt Management Office (“DMO”) will hold its regular bond auction. The series that will be issued are 3M SPN, 12M SPN, 5Y FR95, 10Y FR100, 15Y FR98, 20Y FR97 and 30Y FR89. In the previous conventional auction, incoming bids reached IDR 28.792Tn and DMO issued IDR 15.8Tn.
