DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

STILL UP

JCI slightly strengthened and closed at 6,659 (+25 points or +0.38%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 1Tn today and rupiah slightly weakened to IDR 14,110/USD.

Banking stocks were mostly positive as BBRI (+2.08%), BBNI (+4.81%), BBTN (+7.6%), and BMRI (+0.35%) all rose, except BBCA (-1.63%). Consumer names were mostly positive as GGRM (+2.18%), HMSP (+0.88%), SIDO (+2.58%), and ICBP (+0.27%) all advanced, except UNVR (-2.39%). Pulp & paper stocks were positive as TKIM (+4.71%) and INKP (+1.66%) all advanced. Telco names were mixed as ISAT (+4.62%) closed higher, while FREN (-3.16%) and TLKM (-0.52%) closed lower. Other movers were BBYB (+10.61%), ERAA (+10%), MASA (-6.71%), and BBHI (-6.33%).

As of 17 October, national coal production reached 475mn ton or 76% of 625mn ton target for this year, while coal exports have only reached 48% or 232.7mn of the total 487.5mn ton quota. Meanwhile heavy equipment sales rose by 99% YoY in 8M21 to 8,821 units from 4,440 units, driven by the mining sector of 3,062 units (+206% YoY) followed by forestry (+84%), construction (+64%), agro (+55%).

LIMITED ACTIVITY


Indonesia bond market start the week slightly weaker on the back of 10Y UST yield back to 1.60% level. Nothing much changed in today's trading focus as activity continued to be clustered in 5Y and 10Y benchmark series. However, we still see several trade on longer tenor. Market activity throughout the day was limited. Yield curve moved higher around 1 – 3 bps compared to last Friday closing level. Tomorrow on October 19th MoF will hold regular Sukuk auction of 6M SPNS, 3Y PBS-031, 5Y PBS-032, 13Y PBS-029, and 25Y PBS-028 with indicative target of IDR 5Tn.




