DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

EDGED HIGHER

JCI advanced and closed at 6,632 (+51 points or +0.77%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 463Bn today and rupiah slightly strengthened to IDR 14,258/USD.

Banking stocks were mixed as BBCA (+1.68%), BBNI (+1.44%), and BBTN (+1.99%) in green, while BBRI (-0.24%) and BMRI (-1.41%) retreated. Consumer names were mixed as ICBP (+1.14%), UNVR (+0.68%), and SIDO (+2.31%) rose, while KLBF (-0.61%) and HMSP (-0.5%) weakened. Mining stocks were positive as ADRO (+3.04%), INCO (+0.83%), PTBA (+1.13%), ITMG (+1.34%), and ANTM (+0.42%) all inched higher. Cement names were mixed as SMBR (-2.56%), INTP (-2.56%), and SMGR (-3.28%) closed lower, while SMCB unchanged. Other movers were BNBA (+25%), BBHI (+10.14%), MPPA (-6.61%), and CENT (-3.18%).

Indonesia's 3Q21 GDP is recorded at 3.51% YoY. Growth was seen in the automotive and transportation industry which grew by 27.64% YoY due to the luxury VAT incentive. The chemicals, pharmacy and traditional drugs grew by 9.71% YoY. Basic metals grew by 9.52% due to the increasing production to supply for foreign demand. The foods and beverage industry grew by 3.49% YoY.

FIRMER


Indonesia bond market opened the day firmer after UST rally last Friday. Buying interest are seen in tenor 10Y and longer as 10Y FR87 got taken to 102.5 (6.14%) and 11Y FR91 at 102.8 (6.01%) in the morning session. In second session, we did see some profit takers came in to the market. However, with limited supply due to auction cancellation, market remained well bid until closing time. At the end of the day, bonds yield closed 5 – 7 bps lower across the board. The yield of 5Y/10Y/15Y/20Y benchmark closed the day at mid-yield of 5.05%/6.14%/6.21%/6.87 % respectively.




