# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **HIGHER**

JCI advanced and closed at 6,693 (+35 points or +0.53%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 146Bn today and rupiah was stabilized at IDR 14,297/USD.

Banking stocks were mixed as BBCA (+1.95%), BMRI (+0.7%), and BBNI (+1.07%) in green, while MEGA (-0.78%) and BBRI (-0.24%) declined. Consumer names were negative as KLBF (-0.29%), HMSP (-0.52%), GGRM (-0.85%), INDF (-1.52%), and UNVR (-1.17%) all down. Telco stocks were mixed as ISAT (+3.42%) and TLKM (+0.24%) up, while FREN (-3.16%) down. Material names were negative as TPIA (-0.66%) and BRPT (-2.82%) all corrected. Other movers were MSIN (+8.84%), ARTO (+6.91%), BBHI (-6.95%), and BBYB (-6.15%).

Gov't has allowed 18 ships with 1.3mn ton of coal to do exports. Previously, Coordinating Ministry of Maritime and Investment noted there are 37 ships that have been loaded are ready to depart to the export countries. The ships allowed for exports include coal produced by Adaro, Indika, and Sinarmas group.

## **BOND MARKET**


#### **SOFTER**

Indonesia bond market closed the week with lower yield around 3 – 6 bps. Most of the morning session was muted with bidders turned very defensive. In the afternoon session, buying interest was seen. Market saw buying interest at the front and belly to tail part of the curve which 10Y – 20Y areas of benchmark and non-benchmark series. Positive sentiment came from local banks and interbank. The 5Y/10Y/15Y/20Y benchmark closed the week at mid-yield of 5.17%/6.36%/6.37%/7.02%.


