DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Lower on Close

JCI weakened and closed at 6,813 (-76 points or -1.1%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 438Bn today and rupiah was stabilized at IDR 15,588/USD.

Banking stocks were mostly negative as MEGA (-0.92%), BBNI (-1.08%), BBRI (-1.65%), and BBCA (-2.34%) all retreated, except BMRI (+0.75%). Consumer names were mixed as INDF (+1.48%), MYOR (+3.15%), and UNVR (+0.87%) inched higher, while ICBP (-0.74%) and KLBF (-1.42%) weakened. Mining stocks were mixed as ANTM (+2.5%) and INCO (+2.82%) rose, while PTBA (-2.95%), ITMG (-3.91%), and ADRO (-6.25%) weakened. Telco names were negative as ISAT (-0.79%), FREN (-2.82%), and TLKM (-1.04%) all corrected. Other movers were APEX (+34.48%), SHID (+10.88%), MIKA (-6.86%), and UNTR (-6.76%).

PT Pertamina has adjusted prices for its fuel oil as of 3-Jan. Pertamax is adjusted to IDR12,800/liter, Pertamax Turbo is adjusted to IDR14,050, Dexlite is adjusted to IDR16,150/liter, and Pertamina Dex is adjusted to IDR16,750 from IDR18,800. These new prices applies to provinces with a motor vehicle fuel tax (PBBKB) of 5% such as in the DKI Jakarta area.

BOND MARKET


Little Change

Indonesia bond market traded mixed today. Several unabsorbed bidders turned to secondary market. Market players were keen hunting the fav benchmark series, 10Y FR96. However, several mixed activities were seen especially on 5Y and 10Y non benchmark series but the trade volumes were small until the trading session end. Overall, the 5Y/10Y/15Y/20Y benchmark yield closed the day with yield movement -3/-2/-1/-2.


