

FOR PROFESSIONAL INVESTORS - 06/11/2021 DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

SLIDE LOWER

JCI slightly weakened and closed at 6,095 (-12 points or -0.2%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 2.6Tn today and rupiah slightly strengthened to IDR 14,189/USD.

Banking stocks were mostly negative as PNBN (-1.14%), BDMN (-1.29%), BBRI (-0.47%), and BBCA (-2.27%) all closed lower, except BMRI (+1.21%). Consumer names were mixed as UNVR (+0.94%), KLBF (+0.69%), and ICBP (+0.31%) advanced, while MYOR (-0.78%) and HMSP (-0.82%) down. Mining stocks were positive as ADRO (+8.68%), ANTM (+2.48%), INCO (+2.33%), PTBA (+4.09%), and ITMG (+5.67%) all in green. Poultry names were negative as MAIN (-2.82%), JPFA (-2.38%), and CPIN (-1.43%) all down. Other movers were MLPT (+23.99%), MAPI (+9.15%), CASA (-6.13%), and TBIG (-2.61%).

Ministry of Finance ensured that the VAT imposed to staples will not be high. Note that currently the gov't is considering 3 schemes for rising the VAT, which is 1) single tariff increased to 12% from 10%, 2) multi-tarriff scheme which 5% is imposed for staples and 25% for luxury goods and 3) final tariff of 1%.

BUY AND SELL


Indonesia bond market closed the week with lower yield around 2 – 5 bps post US CPI hit 5.0% (vs. 4.7% market expectation) last night and bring 10Y UST yield down. As soon as market opened, biddish tone was thick in the air. The 5Y FR86 and 10Y FR87 got traded as high as 100.85 (5.29%) and 101.45 (6.29%). Significant price increase soon invited profit takers in market. The benchmark series of 5, 10, 15 and 20Y closed the week at mid yield of 5.33%, 6.33%, 6.29% and 7% respectively.




