DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Slide lower

"JCI slightly weakened and closed at 6,927 (-8 points or -0.12%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net inflow of IDR 150Bn today and rupiah was stabilized at IDR 15,683/USD.

Banking stocks were mixed as BBCA (+0.28%) and PNBN (+2.47%) rose, while MEGA (-0.96%), BBRI (-0.47%), and BBNI (-2.82%) closed lower. Consumer names were mixed as KLBF (+0.57%) and UNVR (+0.55%) inched higher, while MYOR (-0.77%), INDF (-0.37%), and ICBP (-0.91%) closed lower. Properties stocks were negative as PWON (-1.4%), SMRA (-3.31%), CTRA (-2.36%), and BSDE (-3.21%) all down. Pulp & paper names were negative as TKIM (-3.04%) and INKP (-1.86%) all closed lower. Other movers were TCPI (+5.09%), STTP (+4.2%), ARTO (-8.47%), and EMTK (-4.65%).

The government has added to the list of goods that will be subject to import duties as regulated in Minister of Finance Regulation (PMK) No. 96/2023. Previously there were four categories of goods including bags, books, textiles and footwear. There are currently four additional categories including cosmetics, bicycles, watches, and steel.

BOND MARKET


Slightly higher


