# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### RETREATED

JCI weakened and closed at 6,813 (-51 points or -0.74%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 131Bn today and rupiah slightly strengthened to IDR 14.685/USD.

Banking stocks were mostly negative as BBNI (-0.79%), BMRI (-0.48%), BBRI (-0.97%), and BBCA (-1.38%) all corrected, except PNBN (+4.33%). Consumer names were mostly positive as ICBP (+3.37%), INDF (+2.31%), GGRM (+2.18%), and MYOR (+1.95%) all inched higher, except KLBF (-0.48%). Pulp & paper stocks were negative as TKIM (-6.82%) and INKP (-6.54%) all declined. Retailer names were positive as AMRT (+3.09%), MAPI (+3.19%), MAPA (+2%), and ACES (+1.35%) all advanced. Other movers were EXCL (+5.2%), TBIG (+4.17%), PTBA (-6.99%), and UNTR (-6.97%).

OJK to Regulate Carbon Market Mechanism and Carbon Trading. President Joko "Jokowi" Widodo chaired a Wednesday meeting with his staff at the Merdeka Palace, Jakarta. This meeting discussed how to optimize the carbon trading policies in Indonesia.

## **BOND MARKET**


### **FIRMER**

The bond market closed the day firmer on the back of renewed interest as UST yield moved lower overnight. Solid interest that came both from onshore and offshore players gave further support to the market. Buying started in 10Y FR96 that got taken up to 104.0 (6.44%) which quickly followed by longer series 15Y FR75 traded up to 105.95 (6.85%) and 12Y FR80 that changed hands as high as 106.0 (6.76%). Tonight, market awaits for FOMC meeting decision regarding the policy rate and market consensus are at 25bps hike for this meeting.


