INDONESIA MARKET WRAP

EQUITY MARKET

Low(er) Turnover

JCI slightly strengthened and closed at 8,646 (+36 points or +0.42%) today. Shares across regional markets were positive. Meanwhile, foreign investors recorded net inflow of IDR 1.34Tn today and rupiah slightly weakened to IDR 16,776/USD.

Banking stocks were mostly negative as MEGA (-1.21%), BNLN (-1.94%), BBRI (-0.27%), and BMRI (-1.45%) all corrected, except BBCA (+1.55%). Consumer names were mixed as KLBF (+2.08%), INDF (+1.48%), and HMSP (+2.08%) advanced, while ICBP (-0.89%) and UNVR (-2.53%) retreated. Mining stocks were mostly positive as ANTM (+3.91%), INCO (+8.03%), TINS (+4.33%), and INDY (+7.98%) all up, except ADRO (-0.26%). Material names were negative as TPIA (-1.74%) and BRPT (-1.99%) all corrected. Other movers were YULE (+18.52%), BUMI (+14.53%), PANI (-7.39%), and EMTK (-6.94%).

The government is drafting a new presidential regulation to overhaul the distribution scheme of subsidized 3 kg LPG. Linked to national ID numbers, this regulation aims to formalize a closed distribution system up to sub-agents, regulate margins across the supply chain, and define eligible household recipients based on welfare deciles using DTKS data.

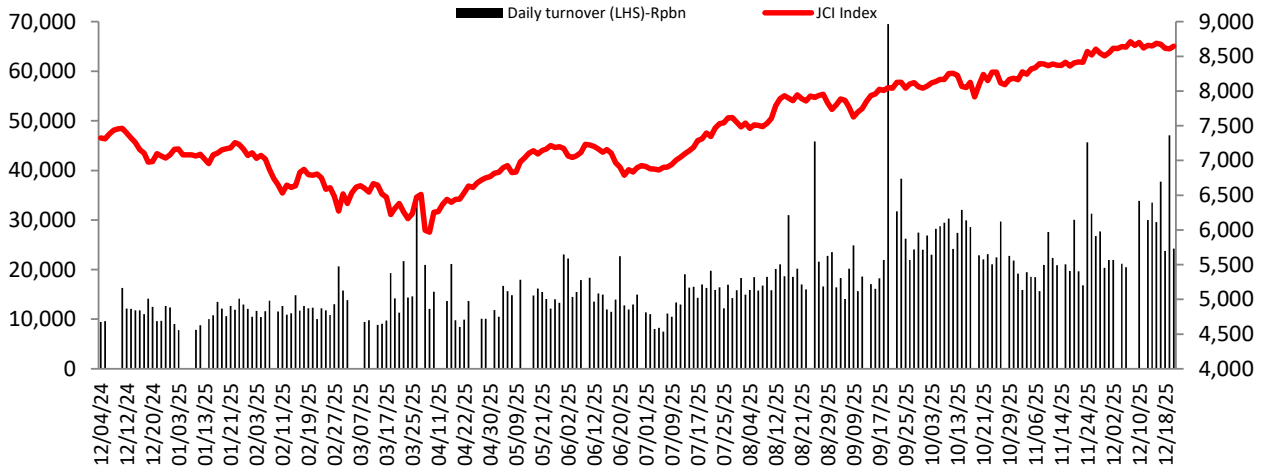
BOND MARKET

Quiet Market

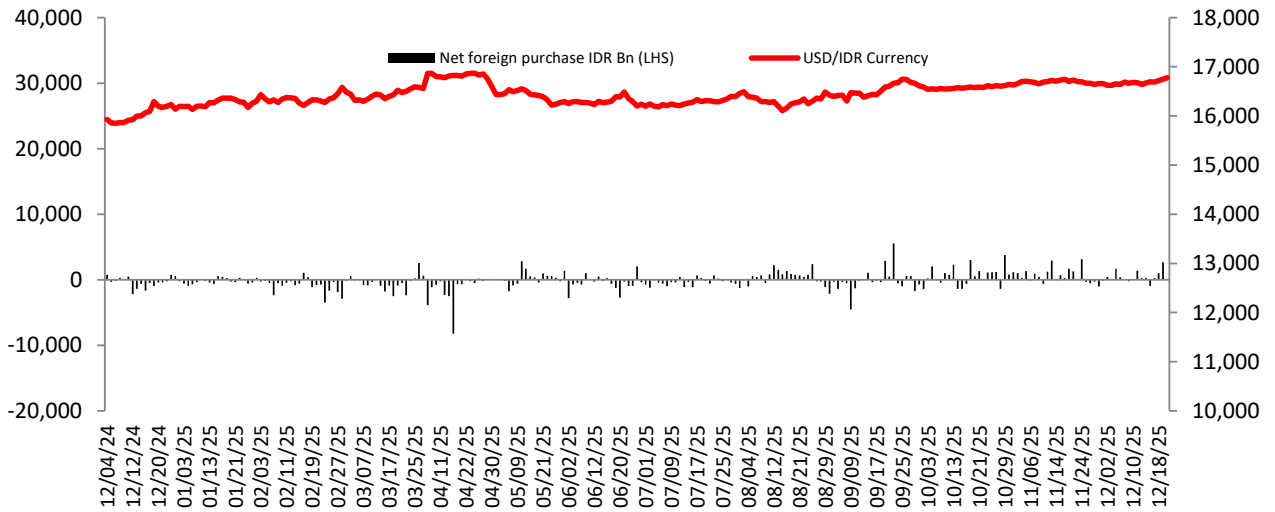
Indonesia bond market was calm today to start this short-week. From our side, only few trades were seen throughout the day with light trading volume. Although the overall market tone was mixed, no significant price action took place. IDR bond the prices ended the day unchanged from last Friday level. The yield of 5/10/15/20Y benchmark closed the day at mid-yield of 5.6%/6.13%/6.42%/6.52% respectively.
