INDONESIA MARKET WRAP

EQUITY MARKET

JCI advanced and closed at 7,606 (+73 points or +0.96%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 850Bn today and rupiah slightly strengthened to IDR 16,274/USD.

Banking stocks were positive as BBRI (+2.97%), BBKA (+3.01%), BBNI (+3.19%), BMRI (+1.07%), and BBTN (+8.07%) all advanced. Consumer names were mixed as ICBP (+2.14%) and HMSP (+2.86%) up, while MYOR (-0.9%), KLBF (-0.36%), and INDF (-0.92%) closed lower. Properties stocks were positive as CTRA (+4.71%), BSDE (+5.39%), SMRA (+6.76%), and PWON (+3.78%) all advanced. Material names were negative as TPIA (-0.28%) and BRPT (-4.47%) all closed lower. Other movers were MLPT (+20%), EMTK (+9.09%), BIPI (-5.32%), and ANTM (-4.85%).

Gaikindo released July 4W wholesale sales at 60.5k units (+4.8% MoM, -18.4% YoY). Cumulative sales in 7M25 reached 435k units (-10.1% YoY), at 48% of Gaikindo's FY target (900k units) and 54% of Astra's guidance (800k units).

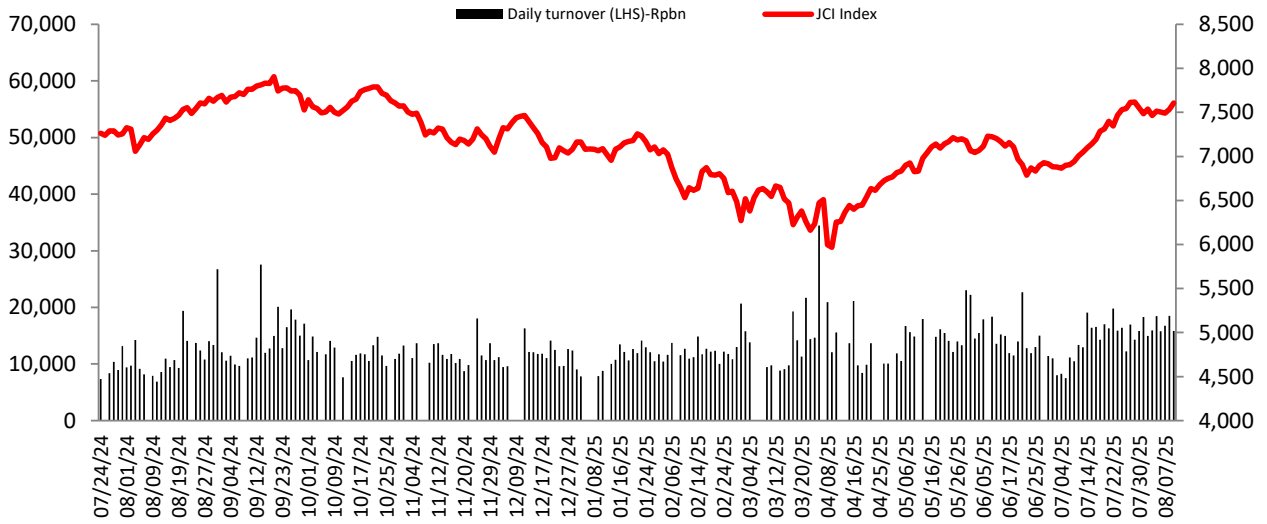
BOND MARKET

A Tad Higher

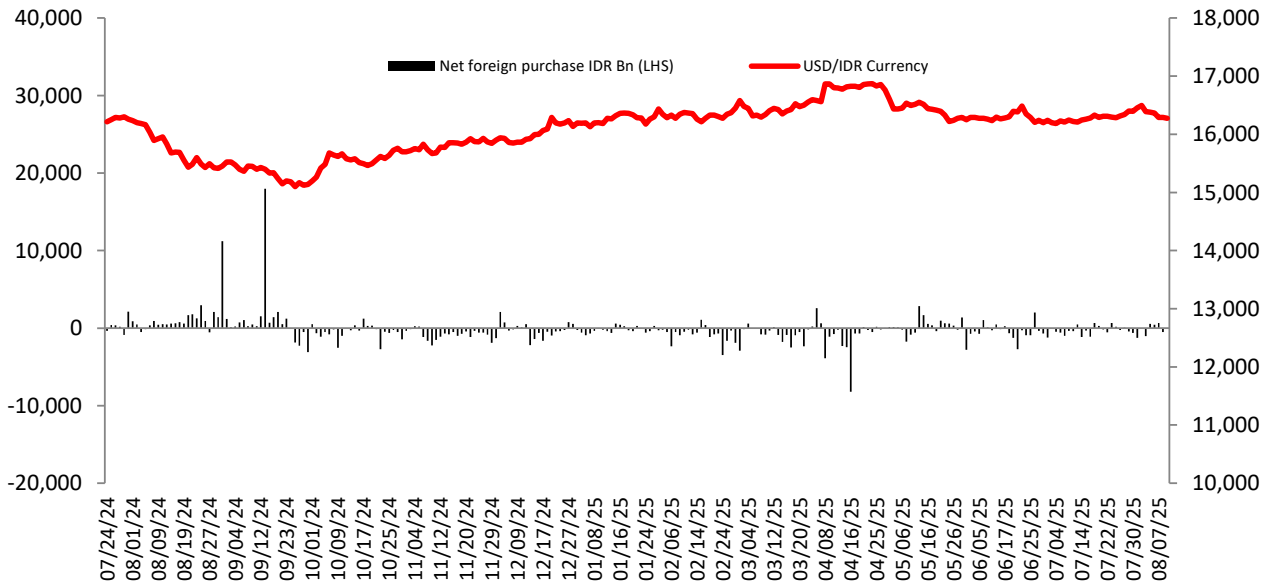
Indonesia bond market start the week with offerish tone. We heard several players unloading their inventory, in what suspected to be a freeing up space as they prepare for tomorrow auction especially with fresh issuance of 5Y FR109. The 10Y and 15Y benchmark series remained the most traded bonds throughout the day. However, some investors had taken opportunity to collecting the front end at the bottom. The 5Y/10Y/15Y/20Y benchmark closed the day at mid yield of 5.93%/6.44%/6.79%/6.83%. There will be fresh supply tomorrow as Indonesia Debt Management Office ("DMO") will hold conventional bond auction with IDR 27Tn issuance target. The series that will be issued are 3M SPN, 1Y SPN, 5Y FR109 (New Issuance), 10Y FR108, 15Y FR106, 20Y FR107, 30Y FR102 and 40Y FR105. In the previous conventional auction, incoming bids reached IDR 106.5279Tn and DMO issued IDR 32Tn.
