DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Slight Rebound

JCI slightly strengthened and closed at 7,148 (+29 points or +0.4%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net inflow of IDR 383Bn today and rupiah was stabilized at IDR 15,498/USD.

Banking stocks were mostly positive as BMRI (+0.42%), BBTN (+0.41%), PNBN (+0.46%), and BNLI (+1.1%) all closed higher, except BBCA (-0.27%). Consumer names were mostly positive as KLBF (+2.17%), KAEF (+15.02%), INDF (+0.4%), and HMSP (+1.14%) all advanced, except ICBP (-0.24%). Mining stocks were mixed as ADRO (+3.59%), PTBA (+1.29%), and INDY (+3.56%) in green, while INCO (-0.48%) and ANTM (-1.8%) down. Retailer names were positive as AMRT (+0.73%), MAPI (+1.49%), ACES (+2.1%), and LPPF (+2.88%) all rose. Other movers were BBYB (+5.83%), PGAS (+3.29%), WIIM (-17.26%), and DSSA (-3.08%).

The government is increasing the excise rate on tobacco products or cigarette excise by 10% in 2024. This amount will come into effect at the beginning of 2024. According to the Director General of Budget at the Ministry of Finance, this increase is in line with Minister of Finance Regulation Number 191 of 2022.

BOND MARKET


Debt Switch

Indonesia bond market closed the day flat. Today, MoF will swap its debt papers with maturities ranging from 1Y to 4.5Y. MoF held Debt Switch with destination bonds FR101, FR100, FR98, FR97 and FR89 and sources bonds FR70, FR77, FR44, FR81, FR40, FR84, FR86, FR37, FR56, FR90, FR59, FR42, FR47 and FR64. Most of the activities centered around today's mixed flows from foreign and local real money players and around today's debtswitch. MoF received the total demand IDR 2.878Tn. MoF swapped a total of IDR 2.342Tn of bonds. Market remained quiet for the rest of the day.


