## INDONESIA MARKET WRAP

---

### EQUITY MARKET

#### Pull Back

JCI weakened and closed at 7,279 (-44 points or -0.61%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 291Bn today and rupiah was stabilized at IDR 15,480/USD.

Banking stocks were mostly negative as BBNI (-0.47%), BMRI (-0.41%), BBCA (-0.8%), and BBRI (-1.32%) all retreated, except MEGA (+0.97%). Consumer names were mostly negative as UNVR (-0.56%), MYOR (-2.02%), INDF (-0.78%), and KLBF (-0.93%) all declined, except SIDO (+2.94%). Mining stocks were negative as INDY (-1.31%), TINS (-2.27%), ITMG (-2.37%), ANTM (-2.02%), and ADRO (-3.21%) all declined. Hospital names were mixed as SILO (-4.17%) and MIKA (-3.32%) down, while HEAL unchanged. Other movers were MCAS (+11.36%), ARTO (+7.85%), CASA (-18.61%), and AMRT (-2.42%).

Indonesia Dec 2023 inflation data was released. Headline inflation eased to 2.61% in Dec 2023 after a rise to 2.86% in Nov 2023. This is below BI's y/e target (~3.0%), but still within the targeted range (2-4%).


### BOND MARKET

#### 1st Auction in 2024


Indonesia bond market opened weaker ahead first auction today as market cautious on higher issuance target. Indonesia bond market traded weaker with Rupiah weakening traded above 15,600 and 10Y UST hit 3.97%. In today auction, government received incoming bids totaling at IDR 39.8Tn, out of which MoF managed to issue IDR 25Tn as per initial target. Post the auction result, small trading was seen and IDR bonds yield closed higher 5 – 8 bps compared to yesterday closing. The series absorbed (against incoming bids) on the auction were IDR 0.8Tn (IDR 2.4Tn) 3mo SPN, IDR 6.7Tn (IDR 10.007Tn) 5Y FR101, IDR 7.6Tn (IDR 8.611Tn) 10Y FR100, IDR 2Tn (IDR 2.849Tn) 15Y FR98, IDR 0.95Tn (IDR 2.271Tn) 20Y FR97 and IDR 3.7Tn (IDR 5.197Tn) 30Y FR102 at weighted average yields of 6.4%, 6.59%, 6.63%, 6.71%, 6.85%, and 6.95% respectively. No winner on 12MO SPN.
