# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

### **Sold Off**

JCI weakened and closed at 6,948 (-152 points or -2.14%) today. Shares across regional markets were mixed. Meanwhile, foreign investors recorded net outflow of IDR 598Bn today and rupiah slightly weakened to IDR 16,285/USD.

Banking stocks were mostly negative as MEGA (-0.95%), BBNI (-0.65%), BBRI (-1.12%), and BMRI (-2.44%) all closed lower, except BBCA (+1.07%). Material names were negative as BRPT (-8.61%) and TPIA (-9.9%) all retreated. Consumer stocks were mixed as ICBP (+1.21%), KLBF (+0.65%), and INDF (+0.41%) up, while HMSP (-1.35%) and UNVR (-1.92%) declined. Mining names were negative as PTBA (-1.56%), ITMG (-2.17%), INCO (-5.54%), ADRO (-1.71%), and ANTM (-6.94%) all declined. Other movers were SMMA (+4.23%), MAPI (+3.45%), ESSA (-10.63%), and MDKA (-8.68%).

President Jokowi mentioned an investor from United Arab Emirates (UAE) and the owner of Emaar Properties is going to invest in the Nusantara capital city (IKN) development. The signing of the investment plan is going to take place in July 2024.

## **BOND MARKET**


## **WEAKENED**

Bond market opened wider as price quotation continued its downward movement from yesterday despite US Jobs data last night. Selling activity mainly done by foreign names on benchmark and non-benchmark series. Post lunch, we have seen few investors had taken the opportunity to collecting at the bottom. Support was seen from the local names. However this support failed to lift the prices. Yield curve closed higher around 4-5 bps. In today SRBI auction, incoming bids were 60.6T IDR. BI sold 23T IDR on SRBI.


