DAILY REPORT INDONESIA MARKET WRAP

EQUITY MARKET

Higher on Close

JCI advanced and closed at 7,239 (+37 points or +0.52%) today. Shares across regional markets were mostly positive. Meanwhile, foreign investors recorded net inflow of IDR 1.46Tn today and rupiah advanced to IDR 15,658/USD.

Banking stocks were mixed as BBRI (+1.74%), BMRI (+1.91%), and BBNI (+0.87%) closed higher, while BBTN (-1.16%) and MEGA (-1.67%) weakened. Consumer names were mostly positive as KLBF (+1.99%), UNVR (+2.26%), INDF (+0.79%), and HMSP (+1.76%) all up, except MYOR (-1.26%). Poultry stocks were positive as CPIN (+4.5%), JPFA (+3.29%), and MAIN (+1.25%) all advanced. Pulp & paper names were positive as INKP (+5.52%) and TKIM (+4.88%) all advanced. Other movers were TCPI (+5.32%), ASII (+3.9%), ACES (-4.09%), and BRMS (-3.95%).

Ministry of energy and mineral resources (ESDM) ensures that the coal supply from domestic market obligation (DMO) is currently still sufficient, despite hundreds of coal mining companies have yet to receive approval on its annual budget work plan (RKAB) for 2024-2026 period.


FLOW DRIVEN

Indonesia bond market closed the week with positive tone. Biddish tone was heard as soon as market opened, led by 5Y FR101 which was taken at 102 (6.41%) followed by long tenor. Selected buying was seen possibly due to overnight UST yield movement and strength of Rupiah. Overall market tone was biddish as local currency touched below 15,700. Next week, on February 5th MoF will hold regular Sukuk auction MoF will hold regular Sukuk auction of 6M SPNS, 9M SPNS, 2Y PBS-032, 4Y PBS-030, 13Y PBS-004, 17Y PBS-039 and 25Y PBS-038 with indicative target of IDR 12Tn.


