# DAILY REPORT INDONESIA MARKET WRAP

## **EQUITY MARKET**

#### **Sell-off**

JCI weakened and closed at 7,215 (-94 points or -1.29%) today. Shares across regional markets were mostly negative. Meanwhile, foreign investors recorded net outflow of IDR 795Bn today and rupiah weakened to IDR 15,855/USD.

Banking stocks were negative as BBNI (-0.2%), MEGA (-2.43%), BBCA (-0.49%), BMRI (-0.78%), and BBRI (-1.75%) all down. Consumer names were negative as INDF (-0.32%), SIDO (-3.33%), UNVR (-1.67%), ICBP (-3.38%), and KLBF (-3.33%) all retreated. Infra stocks were negative as JSMR (-0.22%), TBIG (-0.79%), TOWR (-1.36%), and PGAS (-1.66%) all declined. Telco names were mixed as ISAT (+1.82%) advanced, while FREN (-3.85%) and TLKM (-1.94%) corrected. Other movers were SKRN (+24.6%), MLPT (+19.88%), PANI (-6.94%), and BRMS (-5.45%).

Government and the State electricity company (PLN) targets continuous addition of renewable energy capacity up to 75GW until 2040, from currently 8.8GW capacity. The additional capacity of renewable energy in 1H24 reached 218MW, which is 67% of the target this year at 327MW.

### **BOND MARKET**

#### Lower (still)


Indonesia bond market continued to trade softer today following US CPI data release overnight. The morning session opened with selling pressure, but quite supported by local names bidding in belly area.

10Y FR103 were traded at 98.10 (7.00%) while 5Y FR101 traded at 100.80 (6.66%). The afternoon session however saw another selling in short tenor and 15Y tenor area. Overall, yield curve closed higher by 3-10bps. The benchmark series of 5/10/15/20Y closed the day at mid yield 6.73%/6.93%/7.08%/7.07%.


